ENTRY

The Commission finds:

- Duke Energy Ohio (DE-OH) and South Central Power Company (SCP) are electric suppliers as defined in Section 4933.81, Revised Code.
- (2) Certification by the Commission of the territories of DE-OH and SCP was approved by Entries in Case No. 78-1311-EL-ORD.
- (3) DE-OH and SCP have jointly petitioned the Commission to reallocate their service territories in Williamsburg Township, Clermont County, Ohio. Specifically, they request the following relocation:

On quadrangle map V-7, commencing at the point at the Intersection of Todd's Run Foster Road and Chambers Military Survey No. 2947 and Harvie's Military Survey No. 3345, corner to Donald Jr. and Patricia Moore and William Jr. and Sandra Bradbury; thence South 87 degrees 23 minutes 45 seconds West along the south line of Earl and Ida Sue Walters and Troy and Lois Anderson a distance of 152.69 feet to a stone; thence North 63 degrees 19 minutes 00 seconds West along the south line of Troy and Lois Anderson, and along the north line of William Jr. and Sandra Bradbury a distance of 114.83 feet to a point corner to Troy and Lois Anderson; thence North 14 degrees 24 minutes 00 seconds East along the west line of Troy and Lois Anderson a distance of 32.87 feet to a point in the north right-of-way line of Todd's Run Foster Road, the REAL POINT OF BEGINNING for the annexation; thence from said point of beginning North 58 degrees 22 minutes 14 seconds West along said north right-of-way line a distance of 52.35 feet to a point in the east line of

- (4) In support of their request, DE-OH and SCP state that the lots in the subdivision known as Todd's Run Estates Subdivision are laid out in such a way that the existing boundary line between DE-OH and SCP cuts through several of the lots. The boundary line needs to be reallocated so that a better service plan may be provided by the electric suppliers and to eliminate potential confusion on the part of both the customers and suppliers. DE-OH and SCP are willing to reallocate the boundary lines so that SCP serves the lots in Phase 1 of the development and DE-OH serves the lots in Phase 2.
- (5) Section 4933.83 (E), Revised Code, provides in pertinent part:

Notwithstanding the effectuation of certified territories established by or pursuant to sections 4933.81 to 4933.90 of the Revised Code, and the exclusive right of electric suppliers to serve within such territory, and notwithstanding any other provisions of such sections establishing rights of electric suppliers to furnish electric service, any two or more electric suppliers may jointly petition the commission for the reallocation of their own territories and electric load centers among them and designating which portions of such territories and electric load centers are to be served by each of the electric suppliers.

- (6) No exception to the change described in Finding (3) has been brought to the Commission's attention.
- (7) The Commission finds that granting the requested relief will promote the purposes of Sections 4933.81 to 4933.90, Revised Code, and will further promote the provision of adequate service to all territories and electric load centers affected by the relocation. Accordingly, the Commission shall order the appropriate modification of the territorial boundary of DE-OH and SCP.

It is, therefore,

ORDERED, That the request of DE-OH and SCP to relocate their territory boundary is granted. It is, further,

ORDERED, That the change on quadrangle map V-7, described in Finding (3), be approved to show the boundary line change. It is, further,

ORDERED, That the petitioners provide, within 14 days, two copies of the approved revised quadrangle map V-7 to our Docketing Division to be date stamped and placed in the Commission's map files. It is, further,

ORDERED, That a copy of this Entry be served upon each party of record.
