Revised tariff sheets have been filed with the FCC to amend Verizon Tariff FCC No. 14, Facilities for Interstate Access, in which Verizon North Inc. concurs for intrastate applications.

Transmittal No. 762 – Effective January 5, 2007 With this transmittal, Verizon is clarifying regulations within Contract Tariff Option 20 in its Tariff FCC No. 14. These clarifications pertain to the qualifying services that can be subscribed to contract tariff options; the manner in which the minimum annual revenue commitment ("MARC") is calculated; the manner in which the acquisition reduction amount is calculated; and the effect on the MARC when the customer replaces a qualifying service with another service that is not provided under FCC 14.

No. 11 (FCC11), Contract Tariff Option 20 in its Tariff F.C.C. No. 14 (FCC14), and Contract Tariff Option 1 in its Tariff F.C.C. No. 20 (FCC20). These clarifications pertain to the qualifying services that can be subscribed to these contract tariff options; the manner in which the minimum annual revenue commitment ("MARC") is calculated; the manner in which the acquisition reduction amount is calculated; and the effect on the MARC when the customer replaces a qualifying service with another service that is not provided under FCC1, FCC11, FCC14 or FCC20.

Revisions to these options are filed pursuant to Verizon receiving Pricing Flexibility relief for Special Access Services in qualifying MSAs.
