Dear Senator Zurz,

In your letter dated Sept 15, 2006, you stated that after "considerable confusion over who's jurisdiction the out-of-service fire hydrants were under." They were the ones who dug them up and tagged them out.

Not a credible statement.

According to Mr Scott Blake at the PUCO, The American Ohio Water Company recently bought out Citizens Water Corp who had reportedly neglected the water system in the area. **MY CHECK RECEIPTS** (enclosed) means 4 to 5 years ago.

Not a credible statement.

Even though Mr Scott Blake, per our phone conversation, has assured me the AOWC has done a tremendous amount of maintenance on the water system already, he can't produce one example of any maintenance. With one water tower, 4 fire hydrants, and buying water from the county, this doesn't sound like any maintenance at all.

Not a credible statement.

Also according to Sept 15 letter: When OAWC took over, they tested all the hydrants and found they were not working and have parts on order to repair them. Where are these parts on order from? Iraq?? Are they now admitting these fire hydrants haven't worked for 4-5 years?

Three months ago a crew dug up the hydrants and left the holes open. The crews were then moved to another location. Why?? And why dig them up in the first place if they didn't have the replacement parts (they supposedly ordered 4-5 years ago) and weren't going to fix them then?

Not a credible statement.

Also enclosed is an email from ODOT explaining the construction work in relation to our water problem.

Not a credible statement.

Now we have gone from months to years!!

Why has the PUCO not taken action on this matter and as a member of the Energy & Public Utilities committees, hasn't AOWC & PUCO insulted our intelligence??

If you care to check with the Portage County Water Resources Administration (our new water supplier), OAWC has asked them to back down the pressure to 60psi. due to the system not being able to handle more pressure.

Please find enclosed a letter from the Brimfield Twp Board of Trustees. They have tried numerous times to contact OAWC regarding the water problems. So far they have refused to answer the phone or respond in any way to them.

On a related matter, I would also like the name and office address of the PUCO field person who reported to the school board.

In regard to the "potentially dangerous situation" that still exists, I feel that AOWC and the PUCO has disregarded the lives of the people of Brimfield and you as a member of the Energy & Public Utilities committee.

I really appreciate all the tireless effort Melissa has put into this matter.

I just received word from the Public Utilities Commission of Ohio about the rescheduled Public Hearing for the Ohio American Water Rate Increase Case. The new date for the hearing located at City Council Chambers, 210 Park Way, Ravenna is Thursday, January 4, 2007 at 6:00PM. I have attached the docket entry making the announcement for your review.

Additionally, you had requested information regarding the PUCO's procedure for public announcements. The legislative liaison at PUCO explained that the utility company is required to place a paid announcement in local papers when they make their "prefiling notice", which is basically announcing their intent to file. There is nothing in the Ohio Revised Code that requires the utility company to make any paid announcements of public hearings.

With that being said, the PUCO does their best to get the information to the local papers, and generally, local newspapers will publish the announcement, but it's usually not a front-page item. The PUCO does indeed send out public notices to all local newspapers. They also inform local, television and radio stations. Ultimately, it is the media outlet's choice to run the announcement and is not something the PUCO can control. They did receive a commitment from the radio stations to run an announcement during their news breaks. Unfortunately, they cannot control when or if they say anything, as they do not pay for airtime or advertisements. In many situations like this, most of the participation is a result of grass-roots efforts of concerned citizens like you.

Thank you again for your continued advocacy on this issue. It is an honor to serve you in the Ohio Senate.

Thank you for contacting me regarding the out-of-service fire hydrants in your area. I appreciate your continued attention to this important matter.

This letter is to update you on developments with the fire hydrants since my September 15th correspondence. Since you last spoke with my Aide, Melissa, she has gathered some additional information from the Public Utilities Commission of Ohio (PUCO). In regards to the primary issue of the fire hydrants, I have been informed that the hydrants will take some time to fix, and in order to do so, the water lines running to them must be shut down. Unfortunately, the antiquated system does not include any shut off valves to isolate the hydrants for repairs. As it stands, Ohio American Water Company would have to effectively shut the entire system down to work on the hydrants. The extended time of the repairs is due to two reasons: there is an issue with availability of a few key parts, and Ohio American needs to construct a valve and water main line system that will allow them to isolate the hydrants for repairs. This will allow the company to work on the hydrants and not disrupt other water services. Ohio American is waiting on a crew from another district to finish another project so they can assist with this one. It is my understanding that the PUCO has not yet issued Ohio American a deadline to make the repairs. I have attached a recent Record-Courier article for your information as well.

In regards to the sprinkler system at the new middle school, it is my understanding that the issue is not with Ohio American. When the engineering firm designed the sprinkler system they did not take in to account a pressure test that Ohio American had conducted at the request of the contractor constructing the school. Therefore, when the system was designed, it was done so improperly. The PUCO field person responsible for the region is familiar with this situation, and has reported that the school board is in no way faulting Ohio American for this situation.


Thank you for contacting me regarding the out-of-service fire hydrants and boil alerts in your area. I appreciate the time you took to bring this matter to my attention.

On your behalf, I contacted the Public Utilities Commission of Ohio (PUCO) for information about this situation. The legislative liaison, Scott Blake, contacted the water company, Ohio American, to get information on the fire hydrants and boil alerts. Ohio American explained that the boil alerts were due to the ODOT project in the area. The boil alerts happen in your area because the water main that serves your home is near the road widening project and is sometimes affected by the road work. As you know, there was considerable confusion over whose jurisdiction the out-of-service fire hydrants were under. After several calls, we found that indeed, Ohio American is responsible for the maintenance of the fire hydrants in your area and have had them tagged out of service for sometime. According to Scott Blake at the PUCO, the Ohio American Water company recently bought out Citizens Water Corporation who reportedly had neglected the water system in the area. Accordingly, the hydrants in question were in a state of disrepair. When Ohio American took over, they tested all the hydrants and found these particular ones were not working and have parts on order to repair them.

As you know, I had Scott call you directly to explain the entire situation to you. After his conversation with you, he contacted the PUCO field staff person responsible for your area. The staff member has been directed to do a site visit to your area next week and instruct Ohio American to complete maintenance to the hydrants by mid-October. Further, Scott explained to me that you mentioned a water tower during your conversation. It is my understanding that the water tower is not being used because the required maintenance to restore it to working order is extraordinarily expensive and would cause utility rates in your area to increase substantially.

I hope this information will be of use to you. The PUCO has assured me that they plan to continue to monitor this situation and ensure that these hydrants are put back in service as soon as possible. Unfortunately, they were not aware of this situation until you took the time to bring it to their attention. I very much appreciate your diligence in ensuring this potentially dangerous situation is rectified. If I can be of further assistance, please do not hesitate to contact me. It is an honor to serve you in the Ohio Senate.

But the company isn't planning on losing any money; Cal-Am is seeing to make up those lost profits by raising rates substantially in Sacramento. **Apparently, Cal-Am thinks it can bribe its Larkfield customers.** Larkfield community leaders are reaching out to their fellow Cal-Am ratepayers in Sacramento to build opposition to this sneaky tactic.

Meanwhile, 130 miles south in Felton, Ca, the San Lorenzo Valley Water District, representing Felton ratepayers, has offered Cal-Am \$7.6 million for the water system. If Cal-Am continues to refuse to sell, the community is ready to use eminent domain to acquire the system. Last year Felton ratepayers overwhelmingly approved a bond measure worth \$11 million to finance the acquisition.

Why do Felton residents continue to work for local ownership of their water system? After Cal-Am asked for a 105% rate increase, the California Public Utilities Commission awarded the company a 13% rate increase in its Felton District on November 30, 2006. Felton ratepayers now pay twice as much as their neighbors served by the publicly-owned San Lorenzo Valley Water District.

privatization when it approved a new water contract for the next 27 years.

On November 29 citizens surrounded the legislature, calling for "No to the re-negotiation!" **Police attacked the protesters with rubber bullets leaving 60 wounded and detaining 10, including a 12-year old boy who was brutally beaten.**

The new contract pardons wealthy Suez shareholders for millions of dollars in unpaid taxes and fines for contractual non-compliance, approves new government subsidies to Suez, and raises water rates beginning in April 2007.

Many civil society groups are backing candidate Luis Juez for governor in the January 2007 elections. As a member of city government, Juez helped negotiate approval from city authorities to hold a non-binding referendum on water to be held Dec. 10, 2006. But current Governor Jose Manuel de la Sota pressured provincial leaders to cancel the referendum. Despite these setbacks, citizen groups in Cordoba continue their struggle for water justice.

California Update

Larkfield-Wikiup, located just north of Santa Rosa, CA, is one of many communities seeking to purchase their local water utility from American Water/ Cal-Am before the company is sold on Wall Street.

After the community held back a proposed 36% rate increase to 7%. Sonoma County sponsored a feasibility study on acquiring the water system. **The results are in and the numbers look good for local control:** Cal-Am reaps over \$600,000 every year in profits from its Larkfield customers. **That's a whopping \$250 per connection to pad American Water's bottom line - money that could be kept in the community if the system was locally owned.**

The community is preparing for more than just glossy mailers in the usual American Water public relations campaign against local acquisition. Other communities have accused Cal-Am of employing intimidation tactics against community groups, such as threatening to sue community leaders.

In this case, American Water is seeking to head off the community effort by consolidating its Larkfield and Sacramento districts into one ratemaking district. In an apparent effort to appease customers who are supporting the movement local ownership of their water, Cal-Am is
