
Dear Ms. Jenkins:

On January 16, 2007, United Telephone Company of Ohio d/b/a Embarq ("Embarq") and eleven Secondaries filed a Joint Application to terminate the PEC/SBC relationship and for Embarq to withdraw as a Primary Exchange Carrier in the exchanges served by the secondary companies. Due to a delay in sending customer notices, the Joint Applicants request a change to the effective date of when the agreement terminates from February 21, 2007 to March 5, 2007. This will allow thirty days for customers to change to another Interexchange Carrier for their intraLATA 1+ toll calls.

Also on January 16, 2007 the same Joint Applicants filed to change the billing method for jointly provided private line services from the Single Bill/Multiple Tariff methodology to the Multiple Bill/Multiple Tariff methodology. The Joint Application states that the above agreement will terminate on February 21, 2007.

The Joint Applicants respectfully request that any reference to the February 21, 2007 termination date be revised to March 5, 2007 in the above two cases.
