As a stated condition in the above case, Dominion was required to consult with the Ohio Historic Preservation Office (OHPO) regarding the development of a preservation plan for the house (Ohio Historic Inventory #W00-709-10) and bridge (included in the same inventory number) located at 3437 Garling Road in Wood County, Ohio.

I would direct your attention to the enclosed letter dated August 4, 2006 from the OHPO office accepting the documentation regarding the preservation plan. As requested by OHPO the properties were also advertised for sale in the Toledo Blade and News-Messenger. (See enclosed)

Having satisfied the condition, Dominion plans to demolish the house and leave the bridge in place for the time being.

This is in response to correspondence received May 31, 2006 (received June 5) regarding the above referenced project. The comments of the Ohio Historic Preservation Office (OHPO) are submitted in accordance with provisions of the National Historic Preservation Act of 1966, as amended (16 U.S.C. 470 [36 CFR 800]).

The project involves construction of an electric generating facility. Cultural resources coordination completed pursuant to Ohio Power Siting Board regulations resulted in the identification of two properties determined by consensus to be eligible for inclusion in the National Register of Historic Places. The two properties are the house south of Garling Road, at 3437 Garling Road, also known as the Willman House and the Helm House (Ohio Historic Inventory # WOO-709-10), and, the metal pony truss bridge that is south of the Willman House. The bridge is also located at 3437 Garling Road and is a structure included in Ohio Historic Inventory # WOO-709-10. The Ohio Power Siting Board placed a condition on the permit requiring preservation of these two historic properties under terms of an agreed upon preservation plan. We have reviewed the documentation transmitted with your correspondence, titled "The Willman House and Metal Truss Bridge, Troy Township, Wood County, Ohio: Documentation and Evaluation of Historic Resources" prepared by URS, (not dated, but apparently February 2006). It is our opinion that the documentation fulfills the stipulations of the agreed upon preservation plan. We recommend that the Ohio Power Siting Board consider amending its condition on the permit and we see no reason to object to the demolition of the house and bridge subsequent to permit modification if permit modification is deemed appropriate by the Ohio Power Siting Board.

We understand that the bridge will remain in service and recommend that any maintenance be designed to maintain the character defining features of this structure.

However, we note that this is not intended to be a new condition to be placed on the permit. The documentation provided completes the preservation plan for the bridge. In our opinion, no further coordination with this office is necessary prior to any modification of the bridge, including demolition, that Dominion Resources deems necessary.

There are several technical matters. Please note that the Willman House, at 3437 Garling Road, is Ohio Historic Inventory # WOO-709-10. It is not 33-WO-473 as stated in the documentation. We have made changes to correct this. The number "33-WO-473" is an archaeological site that is located within the generating facility complex, about a half a mile north of the house. The archaeological site is an isolated find, and it was previously established that this site doesn't warrant National Register recognition. Attached please find a map showing the locations and appropriate labels for recorded cultural resources and surveys in this area. Also, the documentation recommends recordation at a HABS/HAER level. We agree that the documentation provided is appropriate, but we don't agree that the documentation meets HABS/HAER levels. Given the age of the house, the qualities that make it significance, and broader preservation goals for this region, we agree that for this one case that the documentation is appropriate. In other circumstances, we might insist on much more stringent documentation standards.

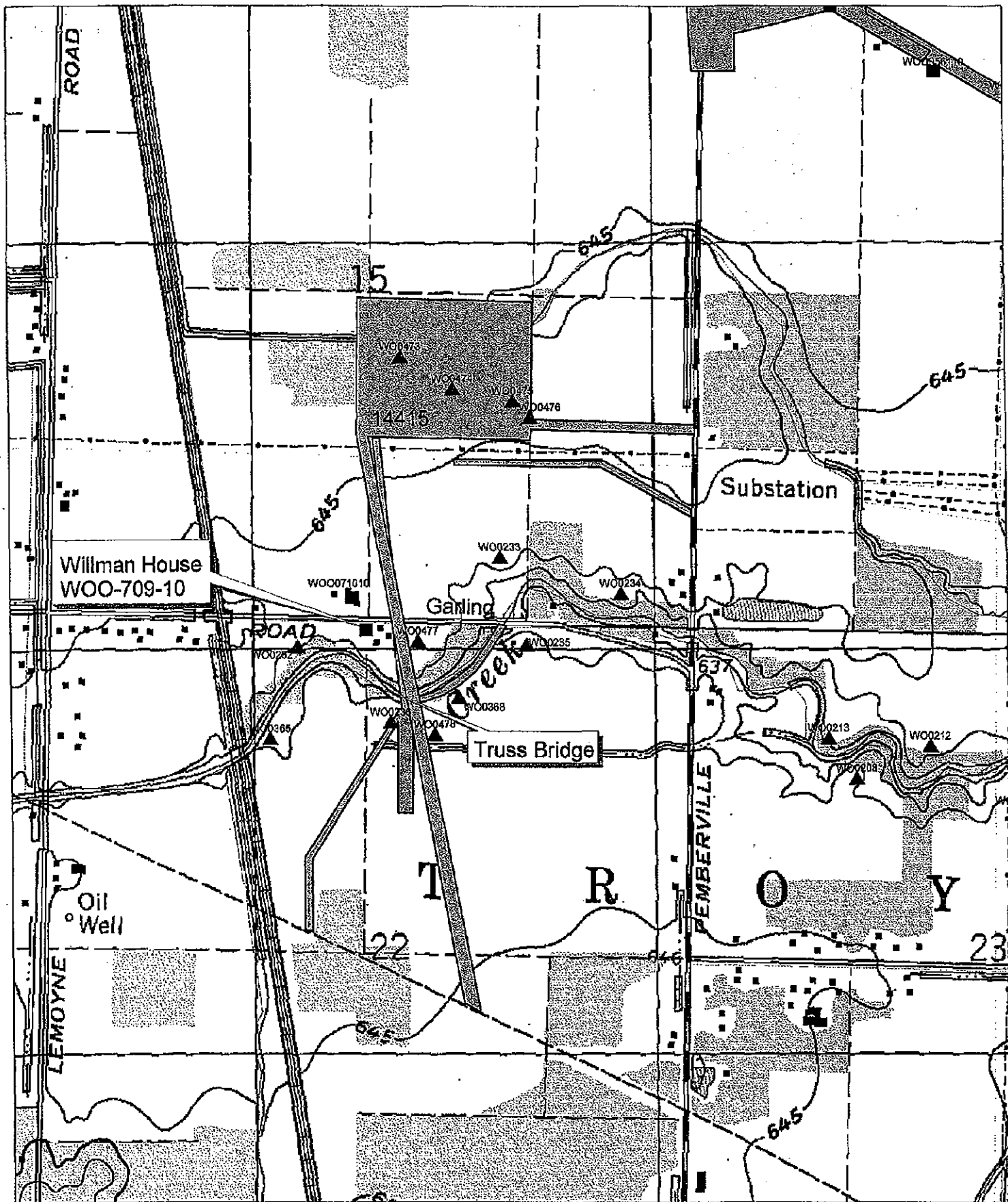

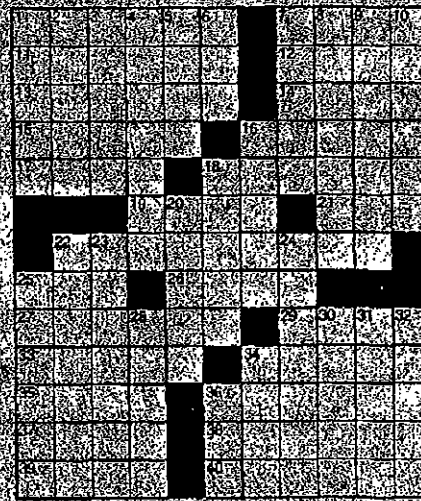
