
Dear Ms. Jenkins:

Enclosed are one original and fifteen copies of a revised Exhibit B previously submitted on January 5, 2007 which proposes to add exceptions to United Telephone Company of Ohio d/b/a/ Embarq P.U.C.O. No. 1 Access Service Tariff. These revisions are filed in compliance with Case No. 07-464-TP-COI.

The following revised tariff page is enclosed:

P.U.C.O. No. 1, Access Service Tariff Section 7 Eighth Revised Sheet 1

On January 5, 2007, Embarq submitted a filing which proposed to add an exception to the Premier Term Discount Plan (PTDP) offering by excluding Ohio's intrastate jurisdiction from the shortfall penalty associate with circuits included in a PTDP. Embarq now proposes to revise Exhibit B with additional exceptions for special access OptiPoint, SONET OC Ring and Ethernet Transport services contained in P.U.C.O. No.1 Access Service Tariff, Sections 7.5.8(C), 7.5.15(B) and (D) and 7.5.16. These exceptions will exclude Ohio's intrastate jurisdiction from the OC3, OC12 and OC48 OptiPoint configuration cards and SONET OC Ring customer and central office interfaces at 10, 20, 50, 100, 150, 300, 450, and 600 Mbps and 1 Gbps levels and the stand alone Ethernet Transport service offering as defined in Embarq Local Operating Companies' Interstate Access Service Tariff F.C.C. No. 1. The OptiPoint configuration cards and SONET OC Ring interfaces at the levels described above are for use with the Ethernet Transport service offering.
