Dear Ms. Jenkins:

On February 16, 2007, Embarq Local Operating Companies filed Transmittal No. 22 with the Federal Communications Commission. The first part of this filing became effective February 17, 2007 and introduced a contract tariff offering in the Las Vegas, Nevada metropolitan statistical area (MSA). The second part of this filing is scheduled to become effective on March 3, 2007 and includes the following revisions to Tariff F.C.C. No. 1:

- 1) Addition of tariff language for switched and special access OptiPoint and special access Ethernet Transport services to clarify that customers can upgrade within those respective services without incurring termination liability charges under certain circumstances;
- 2) Addition of special access rates introducing Ethernet Transport service in the states of Indiana, Kansas, Minnesota, Missouri, Nebraska, New Jersey, Ohio, Oregon, Pennsylvania, Texas, Washington and Wyoming;
- 3) Addition of special access OptiPoint configuration cards and special access SONET OC Ring customer and central office configuration interfaces at 10 Mbps, 20 Mbps, 50 Mbps, 100 Mbps, 150 Mbps, 300 Mbps, 450 Mbps, 600 Mbps and 1000 Mbps (1 Gbps) in the states of Indiana, Kansas, Minnesota, Missouri, Nebraska, New Jersey, Ohio, Oregon, Pennsylvania, Texas, Washington and Wyoming;
- 4) Addition of special construction charges for the installation of fiber optic and copper cable to meet the specific requirements of customers in the states of North Carolina and Texas;
- 5) Removal of a special construction individual case basis filing that was determined to be jurisdictionally intrastate; and
- 6) Addition of rates to provide diverse route facilities in order to meet the specific requirements of a customer in the state of Washington.

It should be noted that some revisions included in Transmittal No. 22 will not affect Ohio's intrastate jurisdiction.




