
SUMMARY OF MAJOR ISSUES
OF
THE CITY OF OXFORD, OHIO

By entry in this docket of February 15, 2007, the attorney examiner directed parties filing objections to the Staff Report to file a brief summary of issues it designates as major issues for purposes of the notice required by Section 4903.083, Revised Code. Pursuant to this directive, the city of Oxford, Ohio ("Oxford") hereby submits the following list of major issues raised by its objections to the Staff Report filed herein this date.

1. The staff's failure to analyze the rates, charges, terms, and conditions of service set forth in Oxford Ordinance No. 2896, the ordinance from which this complaint and appeal was taken, and failure to recommend ratification of those rates, charges, terms, and conditions which were consistent with its recommendations;
2. The appropriate rate of return to be authorized by the Commission;
3. The appropriate allowance for legal expense to be approved by the Commission;
4. The appropriate allowance for rate case expense to be approved by the Commission; and
5. The appropriate allowance for labor expense to be approved by the Commission.
