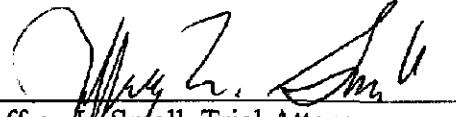
NOTICE OF FILING OF DEPOSITIONS

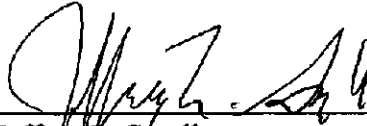
