With regard to MidAmerican Energy Company's (Applicant) application to abandon its certificate to provide competitive retail natural gas service (CRNGS), Certificate Number G02-026 (3), and its operations under that certificate, staff finds that the Applicant has fulfilled its obligation pursuant to Rule 4901:1-27-11 of the Ohio Administrative Code. As such, Applicant's request to abandon CRNGS Certificate Number G02-026 (3), and its operations thereunder, was hereby granted, effective March 1, 2007. The granted application effectively cancels MidAmerican Energy Company's operating authority. MidAmerican Energy Company is no longer authorized to provide CRNGS service in the State of Ohio.


