Enclosed please find an original and ten copies of substitute pages to McLeodUSA Telecommunications Services, Inc.'s ("McLeodUSA") Telephone Tariff No. 2 revision filed on April 2, 2007 (07-360-TP-ZTA). Description:

Removing Busy Line Verify and Busy Line Verify Interrupt:

Busy Line Verify and Busy Line Verify Interrupt are optional features charged on a per use basis. McLeodUSA does not offer these services. Accordingly, these are being removed from the tariff.

Modifying the text for Non-Local Directory Assistance:

Non-Local Directory Assistance is being modified to clarify that this is intrastate DA as opposed to National DA, which is interstate DA. This is just clarification for customers. As an FYI, National DA is addressed in McLeodUSA Interstate Tariff.

Increasing Local Directory Assistance:

McLeodUSA is increasing the Local Directory Assistance for both business and residential customers to \$1.75, which is within the Minimum-Maximum range in our tariff. (See Section 4.3.9, on Sheet No. 98, which is included in Exhibit A for your convenience. Please note that there are no changes being made to this sheet. It is only included for reference.)

McLeodUSA made an error in the first notice regarding the current rate for the Local DA rate increase. As background, McLeodUSA received approval to increase, after providing appropriate customer notice, the Local DA rate from \$0.45 to \$1.25 effective April 8, 2005. However, due to an error on our part, McLeodUSA identified the old Local DA rate of \$0.45 on the notice rather than the current Local DA rate of \$1.25. Thus, the customer notice, included in Exhibit D of the original filing identifies the Local DA increase from \$0.45 to \$1.75 instead of \$1.25 to \$1.75 as it is accurately reflected in the tariff. Upon discovering the error, McLeodUSA distributed a corrected customer notice, which is included in the amended Exhibit D of this filing. This customer notice correctly identifies the current Local DA rate of \$1.25, which is increasing to \$1.75. Please note that the new proposed rate of \$1.75 was and is correct on both notices.

Rationale:

McLeodUSA's rationale for the changes noted above are to help McLeodUSA be competitive within the market place.

In a previous bill message we incorrectly stated \$0.45 as the current rate for Local Directory Assistance in Ohio instead of the correct amount of \$1.25, as indicated in our tariffs on file with the Ohio Commission.
