Dear Magalie R. Salas, Secretary:

As an affected landowner I would like to submit my comments and protests regarding Docket No PF06-30-000.

A REX-East representative recently came to our home - 46775 185th Avenue, Pearl, IL 62361 - to advise us where the pipe-line survey indicates the pipe-line will be placed on our property.

This survey has maximized impact to our property and indicates major inconvenience and destruction would occur if the pipe-line is allowed to be placed where indicated.

It will not only go through our very own back-yard but will also be in very close proximity to our dwelling place.

We Protest Vehemently !!!!!

There are obviously alternative routes which can be taken that would minimize any impact to our property and dwelling place.

This home and surrounding landscaping was physically built and designed by my grandfather and grandmother in 1954. The farm acreage was purchased by them in 1934 and the original farm house they lived in was replaced by the present dwelling they built in 1954.

My mother, Evelyn Maguire, has lived in this house for many years. She lived on this land as a child and returned when her mother was ill and needed her help around 1977. After her mother's death, she remained on this farm to care for her elderly father until his death in 1992. She has remained here since that time. I am her youngest child and have joined her to help her with what I am able to do as she is now 86 years old herself.

It seems to myself and other interested parties it is cruel and thoughtless to propose such destruction to this home when it is obvious the proposed route is not necessary. There is no doubt in our minds that this home could be by-passed far enough to cause minimal impact

without causing REX-East major expenditure or loss of time.

We request that this proposed route be re-evaluated and an alternate plan determined prior to the FERC environmental impact statement for this project to evaluate the environmental impact that could result if it issues REX-East a Certificate of Public Convenience and Necessity under Section 7 of the Natural Gas Act. Because the FERC Pre-filing Process enables review of a project to begin before an application is filed with the FERC and is intended to identify and address project issues as early as possible in the planning and approval period we are acting as promptly as we are aware of these issues.

To expedite the receipt and consideration of our comments, electronic submission of comments was diligently tried without success. I accessed the FERC Internet website under he eFiling link and the link to the User's Guide. I was unable to successfully follow the instructions as written and therefore am submitting this written document.
