#### **ENVIRONMENTAL WEEKLY REPORT**

#### **ENVR - FERC:**

1. Submitted 2<sup>rd</sup> Draft of Resource Report Nos. 1, 2, 3, 8, 9, 10, 11 to FERC.

#### ENVR - FEDERAL, STATE, AND LOCAL ENVIRONMENTAL PERMITTING:

- Meetings held with Huntington District USACOE and OH EPA to discuss 404/10/401 permitting requirements in Ohio. USACOE concerned about EPact2005 requirements relative to NWP 12 authorizations. They believe it may be too early for applicant to submit PCN at same time as FERC application.
- Meeting held with USACOE Deer Creek Lake State Park to discuss results of civil, environmental, cultural surveys and request authorization to perform geotechnical core sampling. Staff believes short-term impact to campground along existing TETCO pipeline corridor outwelghs creating new corridor to avoid campground. Will review with ODNR Parks and Recreation for their input.
- Meetings held with Reynoldsburg USFWS office regarding upcoming survey requirements.
   Surveys will be acceptable for next year's construction period. Also will allow pre-roost tree clearing as method of avoidance to Indiana bats. May require additional mitigation for affected habitat impact.
- 4. Meeting held with City of Barnesville, OH to discuss HDD crossing of Barnesville Reservoir. Officials concerned about potential Impact to drinking water supply system. REX-East believes that the HDD will not impact the drinking water supply system but has agreed to prepare a contingency plan in the event there is an impact to the system.
- Meeting with SNY Levee District regarding the east federal levee at the Mississippi River.
   Whether REX-East crosses over the east levee or under the east levee via an HDD has not been decided. REX-East agreed to provide additional engineering detail for both cases for further discussion.
- 6. Preparation of USCOE 404 Wetland permit and state 401 Water Quality Certification applications continued.
- 7. Continued preparation of draft 401 water quality permit applications for Missouri, Illinois, Indiana, and Ohio.

- 1. Continue development of 404/401 wetland permit applications.
- REX-East Coordination meeting in Houston.

#### **ROW - SURVEY:**

- 1. Survey permitting continues along original route as well as for newly identified properties.
- 2. Agents are attempting personal contacts where landowners' phone numbers are unavailable. Also, letters have been sent to non-resident landowners.
- 3. Decatur and Columbus offices are generating weekly reports as to survey permitting status. Data is revised dally and is incorporated into status reports issued to the Survey/Construction Team.
- 4. Logging of trespass issues continues as they are reported. No incidents of trespass were received during the reporting period.
- 5. New mapping received from GIE and tract by tract review completed and sent back to GIE.
- 6. Work is ongoing to support geomorphic digs. To date, 127 sites have been approved for excavation. To date, 36 digs have been completed in Missouri and Illinois.
