ENTRY

The Commission finds:

- (1) On September 13, 2006 and December 13, 2006, the Commission promulgated revisions to its Rules for Competitive Retail Natural Gas Service in which we, *inter alia*, amended Rules 4901:1-29-06(K)(2 and (3) and 4901:1-29-13(D)(2) and (3), Ohio Administrative Code, to eliminate the GCR adjustments previously applicable to first-time choice customers and former choice customers returning to choice in fewer than sixty days. These GCR adjustments are applied to the customers of Vectren Energy Delivery of Ohio, Inc. ("VEDO") as a rider rate set out in Original Sheet No. 32, Gas Cost Recovery Transition Rider. The revised rules became effective on April 13, 2007.
- (2) On April 17, 2007, VEDO filed an application requesting authority to continue to bill this rider rate, which is currently a credit, through April 30, 2007, and to withdraw Original Sheet No. 32, Gas Cost Recovery Transition Rider effective May 1, 2007. Additionally, VEDO requested approval of Second Revised Tariff Sheet Nos. 11 and 13 effective May 1, 2007. These two revised tariff sheets are proposed in order to eliminate the reference to the Gas Cost Recovery Transition Rider in rates 315 and 325. First Revised Sheet Nos. 11 and 13 would be withdrawn.
- (3) The Commission has reviewed VEDO's application and finds it to be in compliance with the revised rules. We therefore find it is reasonable and in the public interest and should be approved.

It is, therefore,

ORDERED, That the application of Vectren Energy Delivery of Ohio, Inc., for approval of the withdrawal of Original Sheet No. 32, Gas Cost Recovery Transition






