Re: Change in Boundaries between Two Exchanges at AT&T Ohio  
Case Numbers: 07-493-TP-ACB & 90-5032-TP-TRF

Dear Ms. Jenkins:

AT&T Ohio (which is the name under which The Ohio Bell Telephone Company does business) (the "Company") hereby files revised maps of its Franklin and Middletown exchanges, without application, pursuant to Ohio Administrative Code §4901:1-3-03(F). Reduced copies of the revised maps, size 8 ½ x 11, reflecting the proposed boundary changes, are also attached. Both this letter and the reduced maps are being filed in duplicate pursuant to Ohio Administrative Code §4901:1-3-03(G).

The revised maps reflect the incorporation of portions of AT&T Ohio's Franklin into its Middletown exchange. The Company provides the following reason for making this change:

The Middletown Regional Hospital and Premier Health Partners have partnered in the construction of a new regional hospital and development of a new medical complex surrounding the hospital. At this time, the proposed medical development is located in the Franklin Exchange, splitting the complex between the Franklin Exchange and the Middletown Exchange. Inasmuch as the parties desire to have the entire medical complex served by the same exchange, certain boundary changes are necessary. In addition, the Middletown Regional Hospital wants to retain their current Middletown service including the existing telephone numbers they have assigned today. The proposed boundaries for this area are shown on the two attached maps. This change will increase the area served by the Middletown Exchange and decrease the area served by the Franklin Exchange.

The affected area is 25,000' from the Franklin Exchange in the south west corner of the Franklin exchange map and 32,000' from the Middletown Exchange in the east and central section of the Middletown exchange map.


AT&T Ohio can provision the facilities necessary to service this new area as part of the Middletown exchange at half the cost required to provision new facilities as part of the Franklin exchange (\$80,000 vs. \$175,000). The Company confirms that this change will not adversely affect the service being furnished to any existing subscriber.

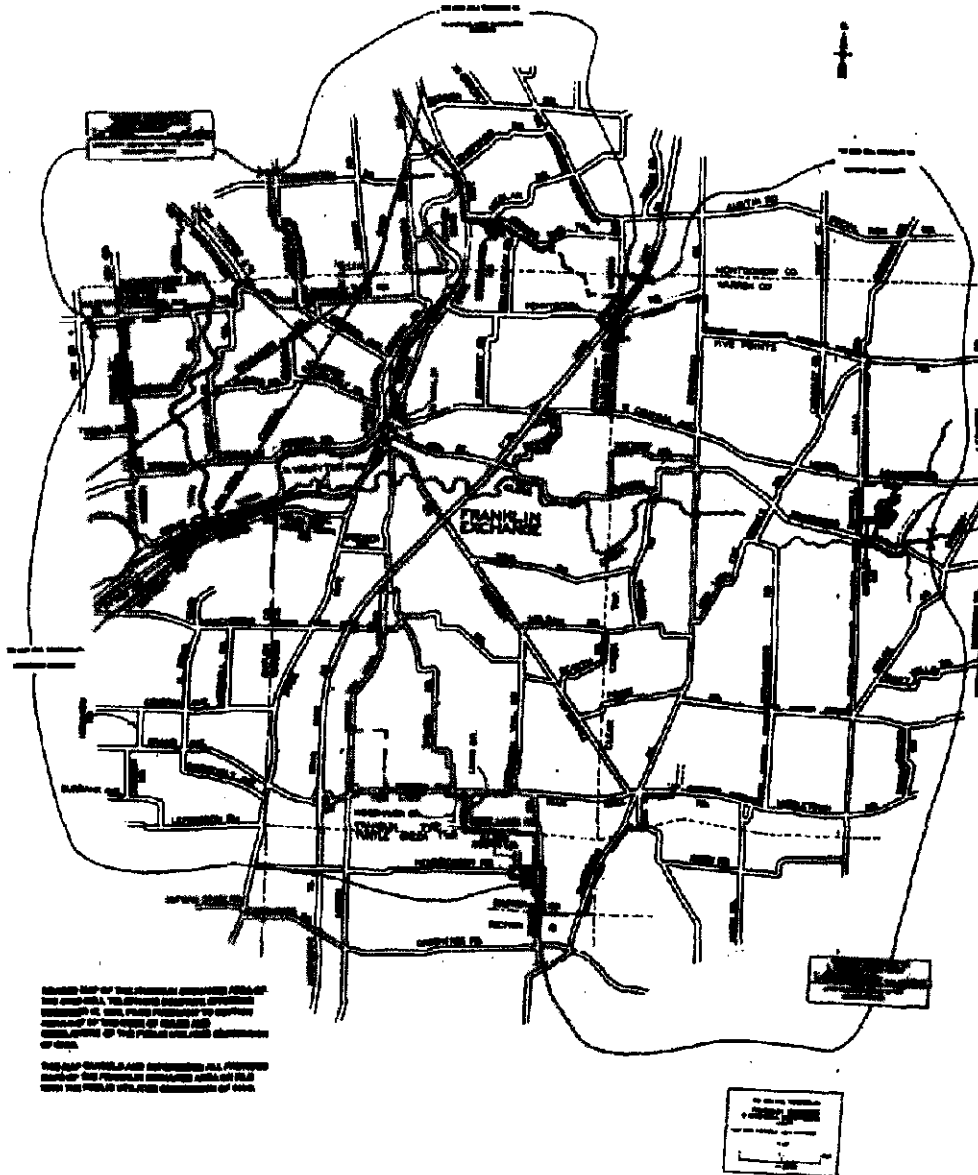

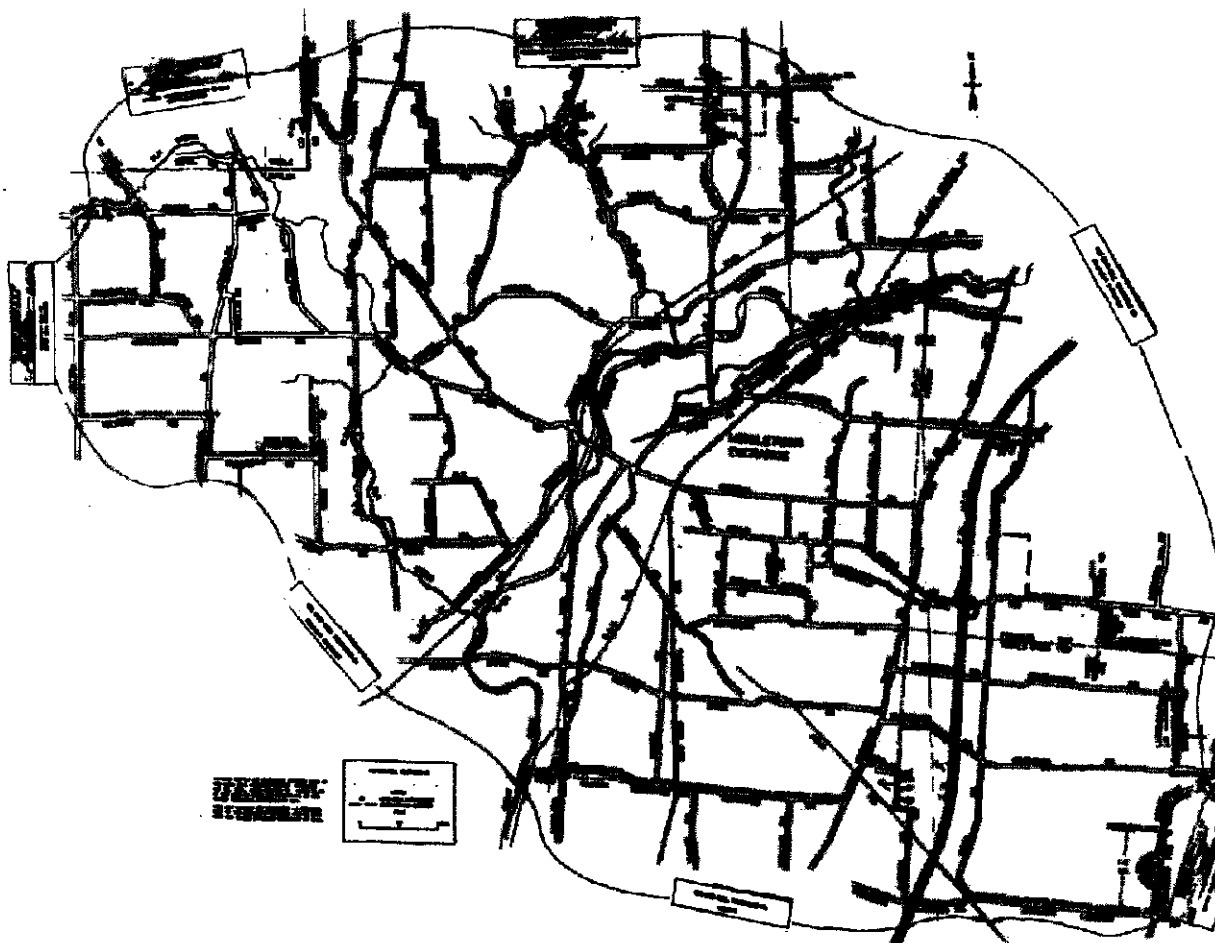
