RE: Joint Application of Trinsic Communications, Inc., Touch 1 Communications, Inc., and Matrix Telecom, Inc. for Approval of a Transfer of Assets; Docket No. 07-411-TP-ATR

Dear Sir or Madam:

Matrix Telecom, Inc. ("Matrix"), through its undersigned counsel, files this letter per the instructions of Mr. Jim Lynn in order to memorialize an e-mail exchange between the undersigned and Mr. Lynn concerning the above-referenced application for approval filed by Trinsic Communications, Inc. ("Trinsic Communications"), Touch 1 Communications, Inc. ("Touch 1"), and any successor in interest of either, including a Chapter 7 bankruptcy trustee (collectively, "Trinsic") and Matrix on April 11, 2007.

Because Trinsic is currently in a Chapter 7 bankruptcy proceeding and is selling its assets to Matrix, Matrix will be the only surviving entity that will operate in Ohio following the closing of the proposed asset transfer. Although Trinsic intends to relinquish its operating authorities, it must of course remain certificated until the closing occurs and will require some period of time to wind down operations. Accordingly, Trinsic intends to notify the Commission within 60 days of the closing of its abandonment of its existing certificates for Trinsic Communications and Touch 1.

In addition, while Matrix plans to provide service pursuant to its own tariff and Trinsic's tariffs as a transitional matter, Matrix intends to adopt the Trinsic tariffs or amend its own tariff as soon as is practicable following the closing.

Prior to closing, Matrix will file the necessary form to expand its certificate to include the territory served by Verizon in Ohio in which Trinsic operates.

As noted in the above-referenced application, Matrix will provide service using the Trinsic brand, possibly on a co-branded basis. Matrix will notify the Ohio Secretary of State regarding its use of the Trinsic brand if it determines that such notice is required.



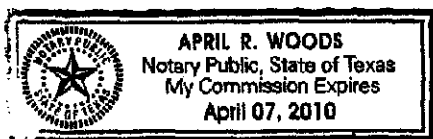
