RE: Change in Boundaries Between Three Exchanges of AT&T Ohio

Dear Ms. Jenkins:

AT&T Ohio (which is the name under which The Ohio Bell Telephone Company does business) (the "Company") hereby files revised maps of its Bellbrook, Centerville and Dayton exchanges, without application, pursuant to Ohio Administrative Code §4901:1-3-03(F). Reduced copies of the revised maps, size 8 1/2" x 11", reflecting the proposed boundary changes, are also attached. Both this letter and the reduced maps are being filed in duplicate pursuant to Ohio Administrative Code §4901:1-3-03(G).

The revised maps reflect the incorporation of portions of AT&T Ohio's Centerville Exchange into it Bellbrook Exchange. A minor update to the Dayton Exchange is also taking place. The Company provides the following reason for making this change:

A new subdivision is going in and we have limited resources to feed it with from the Centerville exchange. Additionally, the distance from the Centerville Central Office is 32,000' whereas, the distance to serve the customers from the Bellbrook Central Office is only 19,000' and we have sufficient feed pairs available. The customers in this new subdivision will be more affectively served from the Bellbrook Central Office.

The area affected by this change is south of Centerville Road between Wilmington Pike and Ferry Road. This will appear in the southwest corner of the Bellbrook Exchange map. The northeast corner of the Centerville Exchange map and the southeast corner of the Dayton Exchange map.

The Company confirms that this change will not adversely affect the service being furnished to any existing subscriber.

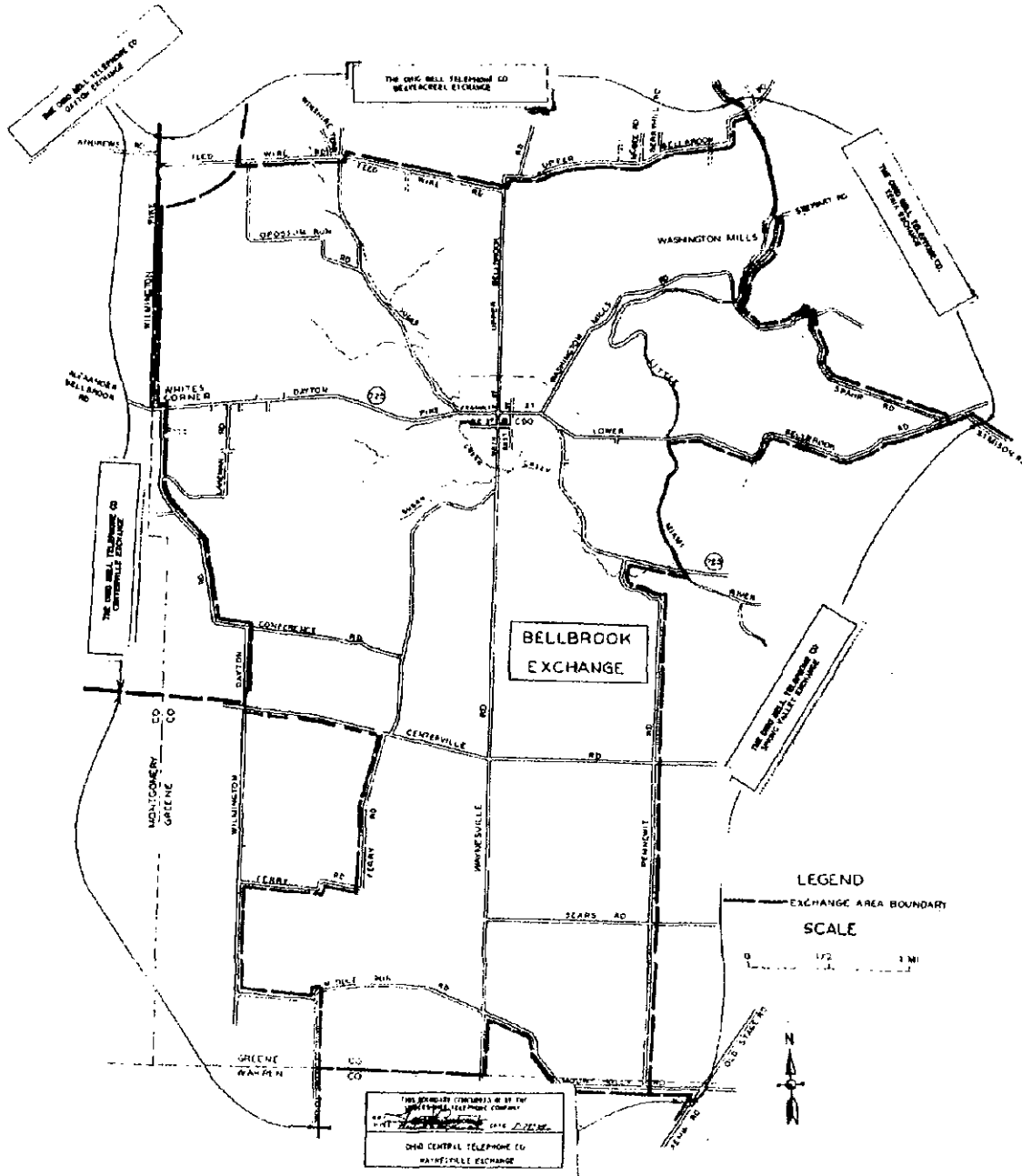

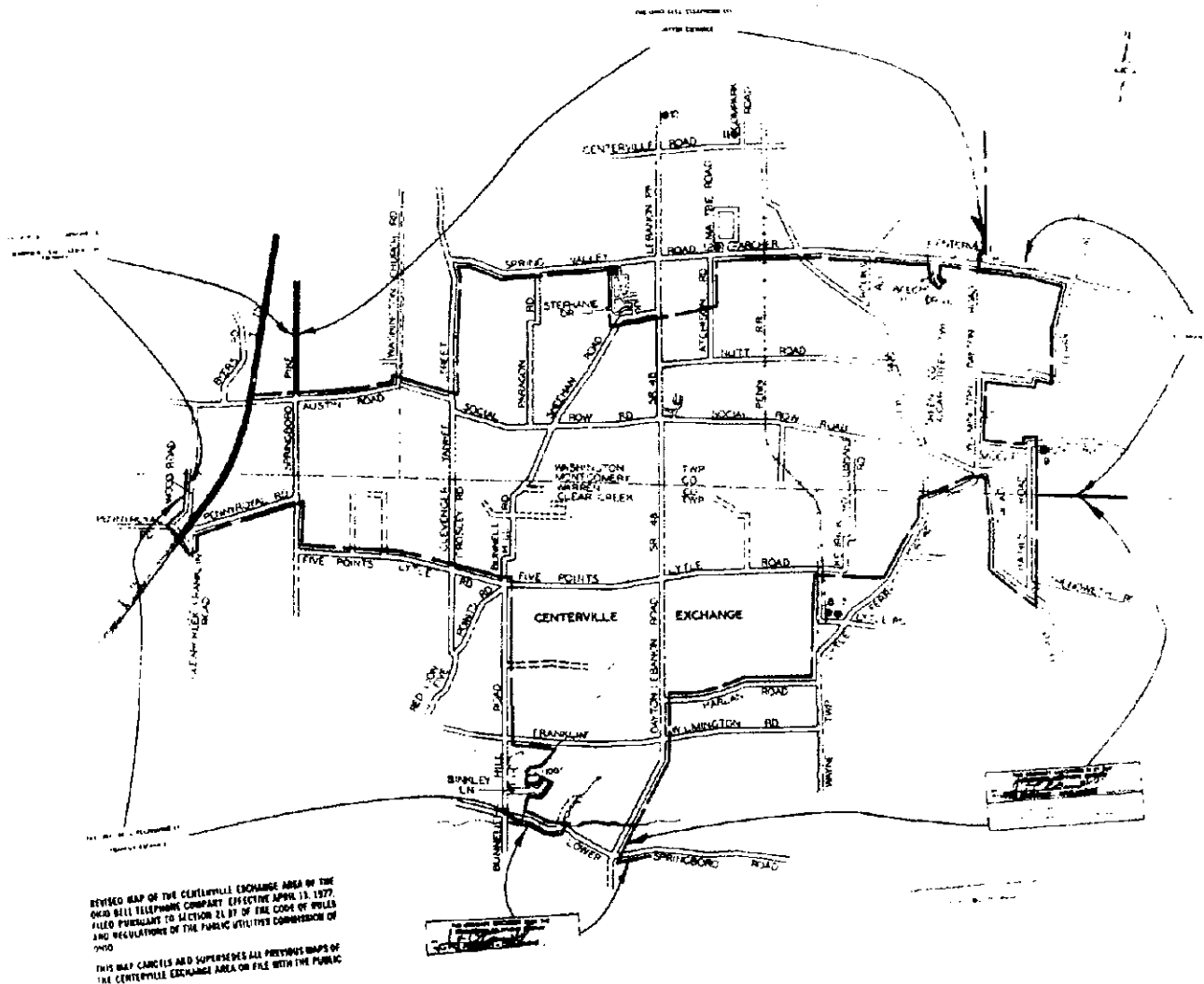

CENTERVILLE EXCHANGE AREA MAP



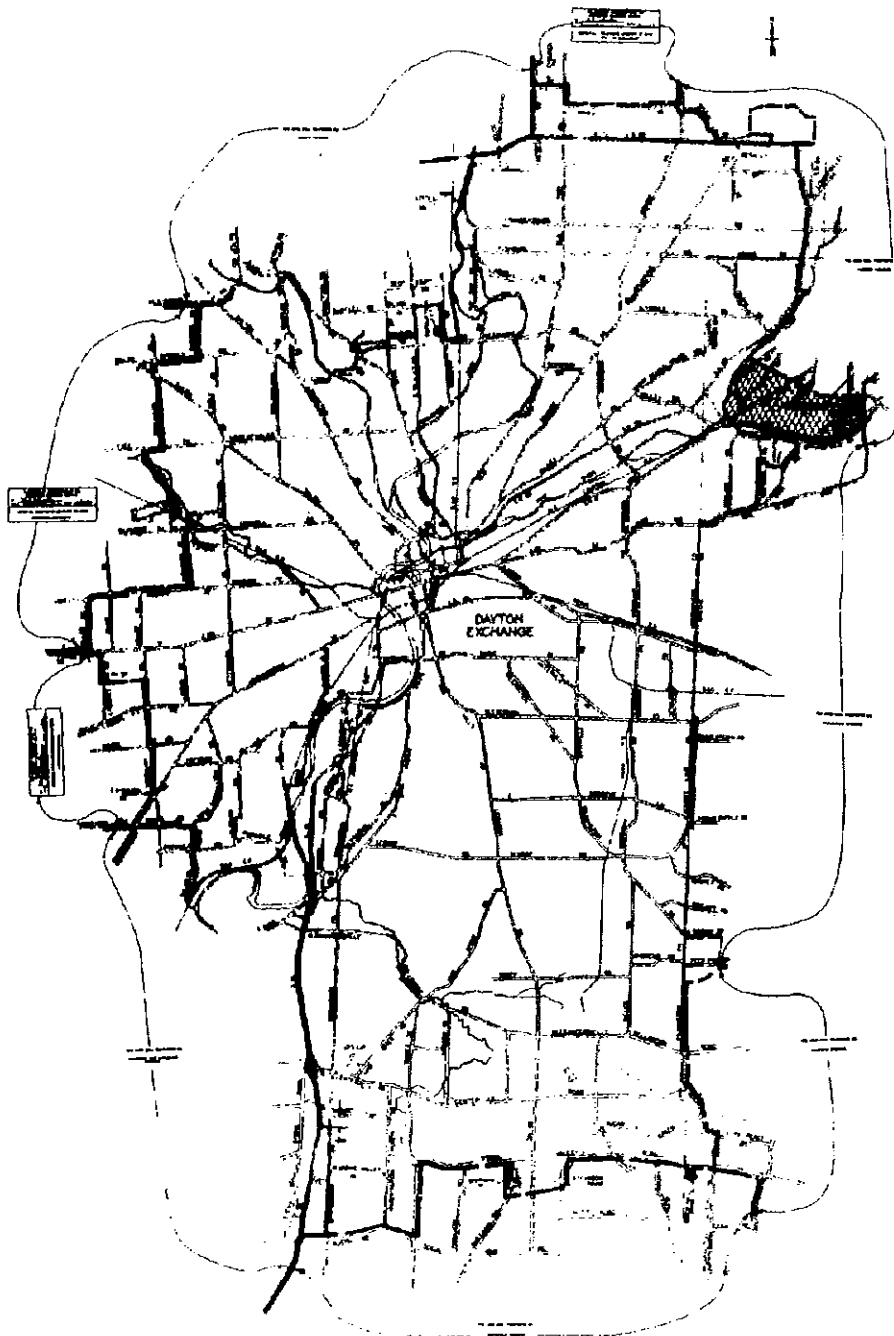
