The Dayton Power and Light Company has filed an application with the Ohio Power Siting Board in Case No. 07-599-EL-BTA seeking to amend a certificate of environmental compatibility and public need issued for the relocation of the Greene-Sugarcreek 138 kV Circuit in Greene County, Ohio. The purpose of the requested amendment is to rebuild and relocate a short section of the Greene-Alpha existing 138 kV transmission line at the Beaver Creek and Sugarcreek Township line where the line crosses Shepherd Road to accommodate a new housing development in the area of the transmission line. The amendment application proposes to change the location of two wood pole structures on the line and the alignment between them.
