
I am writing in response to your April 25, 2007 letter on behalf of your constituent, Peter Yaekle, regarding his opposition to the proposal by Rockies Express to construct a natural gas pipeline on his property in Ohio (Docket Nos. PF06-34-000 and CP07-208-000).

Please know that the Commission will be conducting a thorough environmental review of this project as required by the National Environmental Policy Act and will issue a draft environmental impact statement (EIS) and a final EIS. All environmental and safety comments received during the pre-filing process and in the interim will be considered during the preparation of the draft EIS, which will include our independent analysis of the identified issues. The draft EIS, which will be published and mailed to the stakeholders, residents, commenters, and landowners on our mailing list, will have a 45-day period for review and public comment.

We recognize the concerns of the community, and the Commission staff will conduct several public meetings in the project area to receive comments on the draft EIS prior to publishing the final EIS. Input from you and your constituents during our proceeding is very important to our analysis of the project issues.

If I can be of further assistance in this or any other Commission matter, please let me know.

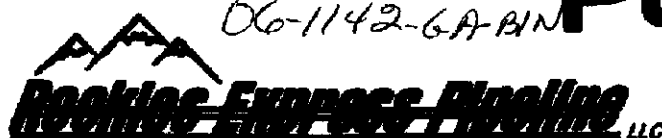
