**NOTICE OF INTERVENTION OF THE

Pursuant to Rules 214(a)(2) of the Federal Energy Regulatory Commission's (FERC) Rules of Practice and Procedure, 18 C.F.R. §385.214(a)(2), the Missouri Public Service Commission ("MoPSC") hereby submits its Notice of Intervention in the captioned docket. In support thereof, the MoPSC states:

II. BACKGROUND

On April 30, 2007, in accordance with its Section 7(c) of the Natural Gas Act and Part 157 of the Federal Energy Regulatory Commission's regulations, Rockies Express

Pipeline LLC (“Rockies Express”) filed an application for a certificate of public convenience and necessity authorizing the construction and operation of approximately 638 miles of new natural gas transmission facilities. The pipeline project, “REX-East”, will extend Rockies Express’ existing transmission system and create a direct link of supplies of natural gas in the Rocky Mountains to major markets in the upper Midwest and Eastern United States. Construction will begin in Audrain County, Missouri and terminate in the Town of Clarington in Monroe County, Ohio.

III. INTERVENTION

The intervenor’s legal name is the Public Service Commission of the State of Missouri. The MoPSC is a governmental agency created under the laws of the State of Missouri, § 386.040 MO. REV. STAT. (2006) with jurisdiction to regulate rates and charges for the sale or distribution of natural gas to consumers in the State, § 386.250 MO. REV. STAT. (2006). It is, therefore, a “State Commission” within the meaning of Section 1.101(k) of the Commission’s general regulations.

The MoPSC wishes to intervene in this proceeding to protect its interests as they may appear and generally to insure that the citizens of Missouri can receive safe, adequate, and reliable natural gas service at reasonable prices with reasonable terms and conditions. Rockies Express, through interconnects with other interstate pipelines and the hub located in Audrain County, Mo, has the potential to serve several investor-owned utility companies regulated by the MoPSC, i.e., Union Electric d/b/a AmerenUE; Laclede Gas Company; and Atmos Energy Corporation. Therefore, the MoPSC has a direct and unique interest in this proceeding and is entitled to party status upon filing this Notice of Intervention pursuant to 18 CFR §385.214(a)(2).

Accordingly, MoPSC hereby submits its notice of intervention pursuant to Rule 214(a)(2).


