## FINDING AND ORDER

The Commission finds:

- (1) Ohio Gas Company ("Ohio Gas") is a public utility and natural gas company subject to the jurisdiction of this Commission by virtue of the provisions of Sections 4905.02 and 4905.03(A)(6), Revised Code.
- (2) On March 28, 2001, Ohio Gas and Campbell Soup Company ("Campbell Soup") entered into a Transportation Agreement for Ohio Gas to provide natural gas transportation service to Campbell Soup to serve its facilities. Ohio Gas acts as transporter for gas delivered onto its system by Campbell Soup and redelivered onto Campbell Soup's facilities as defined in the contract. This agreement was for an initial five-year term starting January 1, 2001 and continuing thereafter from month to month.
- (3) The Commission has reviewed the application under the provisions of Section 4905.31, Revised Code, and finds that the transportation agreement is reasonable and in the public interest and should be approved.

It is, therefore,

ORDERED, That the request for approval of a Transportation Agreement between Ohio Gas and Campbell Soup is granted. It is, further,

ORDERED, That nothing in this Finding and Order shall be binding upon this Commission in any subsequent investigation or proceeding involving the justness or reasonableness of any rate, charge, rule, or regulation. It is, further,

OEDERED, That a copy of this Finding and Order be served upon Ohio Gas and Campbell Soup.
