I have several concerns about East portion (Putnam County Indiana) of the proposed pipeline:

1. What is driving the need for a 42" diameter High Pressure Natural Gas Line? Surely it is not the weak and declining economy of Ohio is it? As for the need for gas transmission lines, it is my understanding the state of Ohio is covered with operating and abandon gas transmission lines.
2. The DBA (50) you are proposing to target is too high - 40 DBA is a basis at other natural gas transmission line locations around the country. This lower rate would be much closer to what residents of Indiana would probably tolerate.
3. The cover over the line should be more than 3 feet in populated areas (for noise control) At some locations around the country operators are using a 10 foot cover over their high pressure transmission lines as a means of noise abatement and to help mitigate human risk.
4. How often are you going to run a pig through the proposed pipe line? I am concerned with associated squealing noise considering your minimum earth cover you are proposing?
5. On the alternate route through Putnam County where will the Compressor Station be located (which was planned for Bainbridge, IN)?
6. A concern I have in general is the proposed line will cross a very special area called the Big Walnut Corridor which is 2600 acres that runs all the way from North Salem


