## **ENTRY**

The Commission finds:

- (1) Ohio Power Company (Ohio Power) and Carroll Electric Cooperative, Inc. (Carroll Electric) are electric suppliers as defined is Section 4933.81, Revised Code.
- (2) Certification by the Commission of the territories of Ohio Power and Carroll Electric was approved by Entries dated September 28, 1983 and May 6, 1981, in Case No. 78-1311-EL-ORD.
- (3) Ohio Power and Carroll Electric have jointly petitioned the Commission to reallocate their service territories in Salem Township, Jefferson County, Ohio. Specifically, they request the following relocation:

On quadrangle map K33-Richmond, relocate the boundary line in Section 30 beginning at a point on the existing boundary line 650 feet north of the south line of Section 30; thence west a distance of 700 feet; thence north a distance of 400 feet; thence east a distance of 700 feet to where it meets the existing boundary line.

- (4) In support of their request, the petitioners state that a golf course has requested Carroll Electric to provide three phase service for additional irrigation pumps. Due to distance from the new pumps, Carroll Electric is unable to provide the three phase service. Ohio Power presently provides three phase service to other pumps at the golf course and is able and willing to provide this service to the additional pumps.
- (5) Section 4933.83(E), Revised Code, provides in pertinent part:

Notwithstanding the effectuation of certified territories established by or pursuant to Sections 4933.81 to 4933.90 of the Revised Code, and the exclusive right of electric suppliers to serve within such territory, and notwithstanding any other provisions of such sections establishing rights of electric suppliers to furnish electric

service, any two or more electric suppliers may jointly petition the Commission for the reallocation of their own territories and electric load centers among them and designating which portions of such territories and electric load centers are to be served by each of the electric suppliers.

- (6) The Staff has reviewed this petition and recommends approval of the boundary line relocation described in Finding (3).
- (7) No exception to the change described in Finding (3) has been brought to the Commission's attention.
- (8) The Commission finds that granting the requested relief will promote the purposes of Sections 4933.81 to 4933.90, Revised Code, and will further promote the provision of adequate service to all territories and electric load centers affected by the relocation. Accordingly, the Commission shall order the appropriate modification of the territorial boundary of Ohio Power and Carroll Electric.

It is, therefore,

ORDERED, That the request of Ohio Power and Carroll Electric to relocate their territory boundary is granted. It is, further,

ORDERED, That the change on quadrangle map K33-Richmond, described in Finding (3), be approved to show the boundary line change. It is, further,

ORDERED, That a copy of this Entry be served upon each party of record.
