MOTION FOR PROTECTIVE ORDER

NOW COMES Clear Rate Communications, Inc. ("Clear Rate" or "Company"), by its attorneys, and hereby moves the Public Utilities Commission of Ohio for a protective order covering certain confidential information submitted in support of the Clear Rate's above-captioned Application for a Certificate of Convenience and Authority ("Application"). In support of this Motion, Clear Rate states as follows:

- 1. The Application for the above-captioned proceeding requires disclosure of documents related to the Company's financial viability. The financial documents (provided as Exhibit I to the Application) are deemed by the Company to be proprietary and confidential;
- 2. Clear Rate is not a publicly traded company. As such, it does not file financial statements with the SEC;
- 3. The statements contain sensitive financial information, which Clear Rate protects from disclosure. This information is not generally available to those inside the Company without specific need-to-know, and the Company keeps it in a secure location to prevent inadvertent disclosure. This information has not been released previously;
- 4. Public disclosure of the information would cause undue harm to Clear Rate and would prove detrimental to Clear Rate's competitive position in the marketplace; and
- 5. Due to the sensitive nature of this information, it is appropriate for the Commission to limit access to such information. The Confidential Information is being provided for the sole use of the Commission in exercising their respective governmental functions by examining the Application. There is no legitimate purpose to be served in

disclosing this proprietary material to any person other than the appropriate reviewing staffs of the Commission.

WHEREFORE, Clear Rate Communications, Inc. respectfully moves that the Commission issue a Protective Order that will limit the availability of Applicant's Financial Qualifications to the above-referenced Application to the reviewing staffs of the Commission.
