Dear Ms. Jenkins:

Revised tariff sheets have been filed with the FCC to amend Verizon Tariff FCC No. 14, Facilities for Interstate Access, in which Verizon North Inc. concurs for intrastate applications.

Transmittal No. 830 – Effective August 7, 2007

With this transmittal, Verizon is revising FCC No. 14 to change the name of Verizon's Primary Interexchange Change Charge to Presubscribed Interexchange Change Charge in order to match the name for the charge as described in part 69 of the FCC's rules. Also, text referencing the minimum period for DSL solutions is being removed from the tariff as the underlying service is not provided under FCC No. 14.

The actual filing documents may be viewed on the FCC's Internet website – www.fcc.gov – by doing the following:

1. On the FCC's main page www.fcc.gov at the top of the page, next to the FCC login, you will find a horizontal list of options. Click on E-Filing.
2. On the next page, scroll down until you see the paragraph on the Electronic Tariff Filing Systems (ETFS) and click on Electronic Tariff Filing System ETFS.
3. On the next page, scroll down to the bottom of the page and click on "Public Access" block.
4. On the next page, click on the "Browse Filed Tariff Documents" block.
5. On the next page, click on the "Browse Documents Filed by an ILEC" block.
6. On the next page, click on "Verizon Telephone Companies."
7. On the next page, click on "FCC14". However, before moving to the next page, you may want to bookmark this page in order to skip Steps 1-6 in the future.
8. On the next page, you will be shown a table of the filings that have been made for that tariff number starting with the most recent. Click on the part of the filing you want to view under the heading "View PDF". Each filing may have several parts, so look for the transmittal number on each line.

With the transmittal, Verizon is proposing the following miscellaneous revisions:

Tariff F.C.C. No. 1:

1. Page 7-245.4. Under Transmittal No. 173, originally issued on April 5, 2002, the title of this service was revised to "45 Mbps Digital Video Transport Service", but was incorrectly shown on this page. The name of the service is being corrected on this page.
2. Pages 7-303.22 and 303.26.2. Under Transmittal No. 546, originally issued on March 2, 2005, IntelliLight® Optical Transport Service Point-to-Fiber-Meet Transport Channels Category I and Category II Unprotected SONET OC192/OC192c 3-Year Term Monthly Rates were introduced with an incorrect USOC. The USOCs are being corrected with this filing.
3. Pages 9-18, 13-87, and 13-88. Under Transmittal No. 23, originally issued on April 13, 2001, column headings on these pages were shown incorrectly. Column headings are being corrected with this filing.
4. Page 16-88.3. Under Transmittal No. 722, originally issued on July 31, 2006, Verizon detariffed its Digital Subscriber Line service. Revision of the reference to this service was inadvertently omitted from this page. The reference is being revised with this filing.

Tariff F.C.C. No. 11:

1. Page 31-3. The USOCs for End User Common Line Single Line Business Subscriber and Primary Residence Subscriber All Other States Monthly Rates are being revised to match New York/Connecticut Monthly Rate USOC.
2. Pages 31-189 and 190. Incorrect USOCs are being corrected with this filing
3. Page 31-265. Additional Labor Stand By Premium Time First Half Hour or Fraction Thereof was reduced to zero under Verizon's 2005 Annual filing, Transmittal No. 589 originally issued on June 16, 2005. A correction is being made with this filing to show "None" under rate column to match the other similar rate categories.
4. Page 31-461. The names of two Port Types contain typographical errors. These errors are being corrected, along with an incorrect USOC.

Tariff F.C.C. No. 14:

1. The name of Verizon's Primary Interexchange Change Charge is being changed to Presubscribed Interexchange Change Charge in order to match the name for the charge as described in Part 69 of the Commission's Rules and as described in Verizon's Tariffs F.C.C. Nos. 1 and 11.
2. Page 3-13. Verizon no longer offers DSL Solutions in its Tariff F.C.C. No. 14. Reference to the minimum period for this service is being removed with this filing.

Tariff F.C.C. No. 16:

1. The name of Verizon's Primary Interexchange Change Charge is being changed to Presubscribed Interexchange Change Charge in order to match the name for the charge as described in Part 69 of the Commission's Rules and as described in Verizon's Tariffs F.C.C. Nos. 1 and 11.
2. Page 42.1. Incorrect page number is being corrected with this filing.
3. Pages 20-310, 20-311, 20-343, and 20-344. Incorrect USOCs are being corrected with this filing.

Supporting material as specified under Section 61.49 of the Commission's Rules is not required with this filing.


