## **McLeodUSA Telecommunications Services, Inc. ("McLeodUSA")**

### **Description:**

McLeodUSA is proposing a price increase for those business customers that currently have a Local Line Price Adjustment and are not served via McLeodUSA local switching facilities. This proposed tariff change reflects the increased costs associated with providing the services to these business customers.

Some background on the Local Line Price Adjustment ("LLPA") to provide some clarity and understanding to the pricing adjustments proposed by this tariff filing. Due to some federal regulatory changes, McLeodUSA applied an LLPA to business customers for each local line that was established prior to January 19, 2006 and was not served via McLeodUSA local switching facilities. The Local Line Price Adjustment did not apply to new Preferred Advantage lines added to their account. An LLPA of \$16.00 for Zone 2 of \$13.00 for Zone 3, and \$12.00 for Zone 4 were applied to each business local line established prior to January 19, 2006 that was not served via a UNE platform.

McLeodUSA did not create a range for the LLPA because we did not anticipate increasing this price prior to the business customers phasing out of their contracts and then moving to the current pricing structure. However, McLeodUSA had not signed the Local Wholesale Complete and the pricing had not been finalized. McLeodUSA is not proposing to increase the LLPA by \$2.00.

### **Rationale:**

McLeodUSA's rationale for the increase of LLPA is to help McLeodUSA be competitive within the market place.

## **McLeodUSA Telecommunications Services, Inc. ("McLeodUSA")**

### **Description:**

McLeodUSA is proposing a price increase for those business customers that currently have a Local Line Price Adjustment and are not served via McLeodUSA local switching facilities. This proposed tariff change reflects the increased costs associated with providing the services to these business customers.

Some background on the Local Line Price Adjustment ("LLPA") implemented in a previous tariff filing. Due to some federal regulatory changes, the TRO and TRRO, McLeodUSA applied an LLPA to business customers for each local line that was established prior to January 19, 2006 and was not served via McLeodUSA local switching facilities. The Local Line Price Adjustment did not apply to new Preferred Advantage lines added to their account. An LLPA of \$16.00 for Zone 2 of \$13.00 for Zone 3, and \$12.00 for Zone 4 were applied to each business local line established prior to January 19, 2006 that was not served via a UNE platform.

McLeodUSA did not create a range for the LLPA because we did not anticipate increasing this price prior to the business customers phasing out of there contracts and then moving to the current pricing structure. Also, the pricing had not been finalized for the old UNE-P product because McLeodUSA was still engaged in negotiations regarding the Local Wholesale Complete Agreement offered by AT&T (SBC). The Local Wholesale Complete Agreement has been executed, and McLeodUSA is proposing to increase the LLPA by \$2.00 for all customers not served via the McLeodUSA local switch facilities..

### **Rationale:**

McLeodUSA's rationale for the increase of LLPA is to help McLeodUSA be competitive within the market place.
