Revised tariff sheets have been filed with the FCC to amend Verizon Tariff FCC No. 14, Facilities for Interstate Access, in which Verizon North Inc. concurs for intrastate applications.

Transmittal No. 836 – Effective August 17, 2007

With this transmittal, Verizon is revising FCC No. 14 to make typographical corrections and text changes to its National Discount Plan, originally introduced under Transmittal 811.

The actual filing documents may be viewed on the FCC's Internet website – www.fcc.gov – by doing the following:

1. On the FCC's main page www.fcc.gov at the top of the page, next to the FCC login, you will find a horizontal list of options. Click on E-Filing.
2. On the next page, scroll down until you see the paragraph on the Electronic Tariff Filing Systems (ETFS) and click on Electronic Tariff Filing System ETFS.
3. On the next page, scroll down to the bottom of the page and click on "Public Access" block.
4. On the next page, click on the "Browse Filed Tariff Documents" block.
5. On the next page, click on the "Browse Documents Filed by an ILEC" block.
6. On the next page, click on "Verizon Telephone Companies."
7. On the next page, click on "FCC14". However, before moving to the next page, you may want to bookmark this page in order to skip Steps 1-6 in the future.
8. On the next page, you will be shown a table of the filings that have been made for that tariff number starting with the most recent. Click on the part of the filing you want to view under the heading "View PDF". Each filing may have several parts, so look for the transmittal number on each line.

On May 25, 2007, Verizon introduced National Discount Plan (NDP) for customers who seek a discount plan that is administered on a national basis as a single plan across Verizon's operating territories under Transmittal No. 811. With this transmittal, Verizon is proposing the following revisions to NDP:

1. For Verizon's Tariff F.C.C. No. 11, rate elements for Banded Base rates of 44.736 Mbps with an Optical Fiber Interface Option at 405 Mbps capacity were inadvertently omitted from the revisions submitted with Transmittal No. 811. Such 405 Mbps capacity Banded Base Rates are being introduced with this transmittal.
2. Several typographical corrections and text changes for NDP are being proposed under this transmittal for Verizon's Tariffs F.C.C. Nos. 1, 11, 14, and 16.

Support material as described under Section 61.49 of Commission's Rules is not required with this filing. However, attached to this filing are the following:

- Figure 1 will be used in the 2008 Annual Filing to demonstrate the new rate element being introduced in Tariff F.C.C. No. 11.
- A document is attached which provides a detailed description of all the typographical corrections and text changes proposed under this transmittal.


This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).
