MOTION FOR PROTECTIVE ORDER


Pursuant to Ohio Administrative Code 4901-1-24.D Intrado Communications Inc. ("Intrado") moves the Commission to enter a Protective Order prohibiting any disclosure to the general public of any portion of Exhibit D to the Company's UNC application for Authority to Provide 9-1-1 Emergency Services throughout the State of Ohio. Intrado requests that the Protective Order specifically state that these documents be disclosed only to Staff members directly involved in this case, and that any pleadings or other filings that incorporate, reference or attach the documents or any portion thereof be submitted under Seal.

As grounds for this motion, Intrado states that the information contained in Exhibit D is required to be submitted to the Commission as part of the Company's Application. The information contained in Exhibit D provides information on the Company's emergency services processes, call processing and other information proprietary to Intrado as part of its next-generation offerings. Public disclosure of this information would materially damage the competitive and financial positions of Intrado. Further, the public interest would be impaired by public disclosure of the information contained in Exhibit D, in that any compromise of the competitive positions of Intrado, vis-a-vis its competitors, would ultimately work to the detriment of the consuming public.

For the foregoing reasons, Intrado Communications Inc. requests the entry of a Protective Order containing the terms and conditions set forth above, relative to its Service Description contained in Application Exhibit D, and for all other appropriate relief.
