COLUMBIA GAS OF OHIO, INC.**

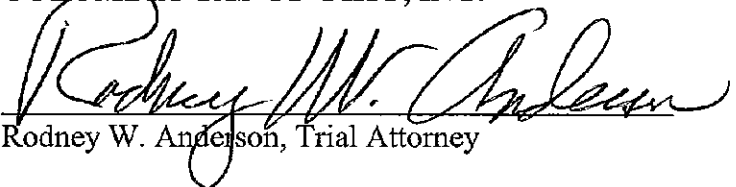
Now comes the Respondent, Columbia Gas of Ohio, Inc. ("Columbia"), and files its Supplemental Post-Order Reply in this proceeding pursuant to Ohio Administrative Code Section 4901-1-31 and the Public Utilities Commission of Ohio's Opinion and Order issued April 4, 2007 ("Order").

On July 2, 2007, Columbia filed its Post-Order Reply to address *inter alia* the calculation of the refund with interest due the Complainant in accordance with the Order. Subsequently, Columbia conducted a further review of those calculations and has determined that the interest calculation for the refund should have been compounded. Therefore, attached hereto is a revised calculation of the interest due on the refund, which demonstrates that the total refund with the interest compounded is \$24,172.62. The compounding of the interest results in an increase of \$1,278.80 in the amount of the refund due over the amount as calculated in Columbia's July 2, 2007 filing.

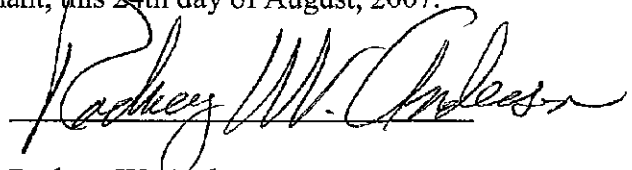
