Revised tariff sheets have been filed with the FCC to amend Verizon Tariff FCC No. 14, Facilities for Interstate Access, in which Verizon North Inc. concurs for intrastate applications.

Transmittal No. 848 – Effective September 5, 2007

With this transmittal, Verizon is revising FCC No. 14 to reduce some rates for the FiberConnect Optional Payment Plan (OPP), Special Access Line – Electrical Interface rate elements. In addition, Verizon is introducing pricing flexibility rates for the FiberConnect OPP in California, Illinois, Indiana, and Texas.


The actual filing documents may be viewed on the FCC's Internet website – www.fcc.gov – by doing the following:

1. On the FCC's main page www.fcc.gov at the top of the page, next to the FCC login, you will find a horizontal list of options. Click on E-Filing.

8. On the next page, you will be shown a table of the filings that have been made for that tariff number starting with the most recent. Click on the part of the filing you want to view under the heading "View PDF". Each filing may have several parts, so look for the transmittal number on each line.

With this filing, Verizon is reducing some of the rates for the FiberConnect Optional Payment Plan (OPP), Special Access Line - Electrical Interface rate elements. In addition, Verizon is introducing pricing flexibility rates for the FiberConnect OPP in the states of California, Illinois, Indiana, and Texas, which now qualify for Level II, Phase II regulatory relief, pursuant to receiving Pricing Flexibility in specific Metropolitan Statistical Areas (MSAs)¹.

Also in this filing, Verizon is removing the FiberConnect OPP, Special Access Line - Optical Interface option. There are no current customers utilizing the Optical Interface option.

With this filing, the FiberConnect OPP, Special Access Line - Optical Interface rate elements are being removed from Price Caps. There is no base period demand for this service, and the Price Cap indices are not changed as a result of this filing. See Workpaper FiberConnect Removal Detail and Workpaper Indices Comparison. Support material, as specified in Section 61.49 of the Commission's Rules, is attached.

In addition, Figure 1, provided as an attachment to this filing, will be used in the 2008 Annual Filing to demonstrate the FiberConnect OPP, Special Access Line - Electrical Interface rate elements are being introduced in the jurisdictions of California-West Coast, Idaho, Michigan, Ohio, South Carolina, and Wisconsin in Tariff F.C.C. No. 14.

Also, Figure 2, which illustrates the services for which pricing flexibility rates are being introduced, is attached. For each service included in this filing, Figure 2 lists the price cap service category into which the service was added.

This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).


