AMENDMENT TO AQUA OHIO'S APPLICATION
FOR APPROVAL OF A NEW BILL FORMAT

On February 16, 2007, Aqua Ohio, Inc., ("Aqua") filed the instant application with the Public Utilities Commission of Ohio ("Commission") to comply with a Commission directive that directed water companies to submit revise bill formats to include contact information for the Ohio Consumers Counsel ("OCC"). On May 2, 2007, Aqua filed supplemental information in the above-captioned docket to include a new bill format for each of its tariffed divisions due to institution of a new billing system.

The Supplemental filing stated that Aqua will use the same bill format for each tariffed division. It further included as Supplement Exhibit A proposed front of the new bill format for each of its tariffed. Supplemental Exhibit B was the proposed back of the new bill format for each of its tariffed divisions. A revised Subject Index page for each of the tariffs noting the revising of the customer bill format was with the initial filing on February 16, 2007 as Exhibit C.


After discussions with the Commission Staff regarding the proposed bill format filed with the Supplemental filing on May 2nd, Aqua has revised the front and back of the proposed bill format. Attached hereto and incorporated by reference as Amendment Exhibit 1 is a revised front and back of the proposed bill format that addresses the comments raised by the Staff.

Amendment Exhibit 1 includes the front and back of the postcard bill format and replaces Supplemental Exhibit A and Supplemental Exhibit B. 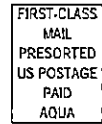

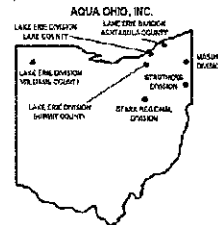
