The attorney examiner, in accordance with the authority granted by Rule 4901-1-14, Ohio Administrative Code, finds:

- (1) On July 10, 2007, the Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (collectively, the "Companies") filed their application in the above-captioned proceeding seeking approval of a competitive bidding process (CBP) designed to procure supply beginning January 1, 2009, for the provision of Standard Service Offer electric generation to the Companies' retail electric customers who do not purchase electric generation service from a competitive supplier.
- (2) On August 8, 2007, Citizen Power filed a motion to intervene and memorandum in support. The Companies filed a memorandum contra Citizen Power's motion for intervention on August 23, 2007.
- (3) On August 31, 2007, Citizen Power filed a motion, by facsimile, for an extension of time to reply to the Companies' memorandum contra. Citizen Power's motion requests an extension of time for ten days, until Friday, September 14, 2007. Also in its motion, Citizen Power asserts that counsel for the Companies does not object to the ten day extension of time. Citizen Power further asserts that the extension of time will not delay or impede this proceeding.
- (4) The Attorney Examiner finds that Citizen Power's motion is well-taken. Accordingly, Citizen Power shall have an
