

Citizen Power's
Motion for Extension of Time to Reply
To the Companies' Memorandum Contra
Motion to Intervene

Citizen Power hereby respectfully moves the Public Utilities Commission of Ohio ("Commission"), pursuant to Section 4901-1-13 Ohio Administrative Code (OAC), for an extension of time to reply to the "Memorandum Contra Citizen Power's Motion to Intervene" filed by the Applicant Companies. Citizen Power requests an extension of ten (10) days, until September 14, 2007, to file a Reply. Applicant's counsel has agreed to the extension by telephone.


Citizen Power filed a Motion to Intervene in this proceeding on August 8, 2007. The Companies filed their Memorandum Contra Citizen Power's Motion on August 23, 2007. Pursuant to the Commission's Rules, Citizen Power has seven (7) days, plus three (3) days after the mailing of the Companies' Memorandum, to respond to the Memorandum. Due to the Labor Day holiday, Citizen Power's reply would be due on Tuesday, September 4, 2007.

Citizen Power requests an extension of time for ten (10) days, until Friday, September 14, 2007, to file its reply. Counsel for the Applicant Companies agreed by telephone to the extension. No parties will be adversely affected by the extension, and the extension will not

delay or impede this proceeding. The harshness and finality of the potential denial of Citizen Power's right to participate in this proceeding justifies the granting of Citizen Power's Motion for an Extension.

Wherefore, Citizen Power requests an extension of time until September 14, 2007 to reply to the Applicant Companies' Memorandum Contra Citizen Power's Motion to Intervene.


