The accompanying tariff material, issued by Ameritech Operating Companies (Ameritech) and bearing Tariff F.C.C. No. 2, is sent to you for publication in compliance with Section 69.727 of the Commission's Rules and the requirements of the Communications Act of 1934, as amended. This filing is being submitted on one day's notice in compliance with Section 69.727 of the Commission's Rules and the requirements of the Communications Act of 1934, as amended.

This filing, scheduled to become effective September 8, 2007, consists of the tariff pages as indicated on the following Check Sheets:

With this filing, Ameritech is proposing to add material to its Metropolitan Statistical Area Access Services (MSA) tariff section to reflect changes resulting from Ameritech's 2007 Annual Access Filing, effective June 30, 2007. New services were incorporated into the appropriate basket or service category and were granted Phase II regulatory relief in qualifying areas, pursuant to Subpart H of Part 69 of the Commission's Rules. As a result, this filing will include enhancements to Dedicated SONET Ring Service (DSRS), Optical Carrier Network (OCN) Point-to-Point Service and Multi-service Optical Network (MON) Ring Service, as described below.

- 1.) Adding new features, DS-3 Transmux Port at OC-48 and OC-192, DS-3 Transmux Re-Map Port at OC-3, OC-12, OC-48 and OC-192, Re-Map Add/Drop Capability at OC-192, Re-Map per Optical-to-Electrical DS-3 Add/Drop Capability to OC-192 and STS-1 to EC-1 ports at OC-3, OC-12, OC-48 and OC-192 to DSRS; and deleting the existing footnote associated with the DS-3 Transmux Port. This footnote previously restricted customers to the OC-3 and OC-12 ring levels. This limitation has been removed as the DS-3 Transmux Port is now available at all ring levels.

- 2.) Clarifying the application of diversity rates (protection and per quarter mile), to the existing OCN Diversity option. The name of the "1+1 Protection with Diversity" feature will be changed to "Diversity." References to Protection (P8T) and Per Quarter Route Mile (S2DXY) were removed, and the existing footnote was removed and replaced with a more clarifying footnote explaining when the Per Quarter Route Mile is applicable. The rates for the Diversity per Quarter Route Mile feature, at the OC-12/12c and OC-48/48c level, were reduced.
- 3.) Expanding the interface options available for the MON Ring offering. Also included are the Reduction of 3-year and Monthly Extension rates for ISC-1<sup>TM</sup> protected channel, the addition of new rate elements – Sub-Rate System, Digital Video Broadcasting (DVB-ASI), ISC-1<sup>TM</sup> protected channels, and ISC-3<sup>TM</sup> protected and unprotected channels. Several non sub-rate interface options are also being added, as well as the movement of existing material for clarity.


None of the proposed changes included in this filing adversely affect existing customers.
