Dear Commission Members: (PLEASE READ)

We are affected landowners' on the proposed route of the referenced docket, Rockies Express East. We understand FERC has requested REX to provide them with an estimate of the extent to which Eminent Domain will be needed on this project. Since we do not expect REX personnel to poll the landowners to provide an accurate estimate, we are informing you that we intend to force REX to use eminent domain to acquire the easement across our property. We feel this pipeline route is going in the wrong area, and do not feel that ruining our land is in our best interests or that of this country.

We pressed charges against REX pipeline, specifically naming the lead surveyor, last year for damage to private property, and criminal trespassing. The last information I received from the Franklin County D.A was that the charges were set for trial in an Indianapolis Indiana Court. This is the truth of those events which REX denied to your office in writing as I have read on a previous filing. I can't even begin to express in words the manner in which we were treated. The thought of dealing with them on a continual basis is more frightening than you can imagine. They tell one lie after another, and look you square in the face while their doing it. REX treats land owner's as though the law doesn't apply to them!

They are going through the middle of our farm. We had high hopes when we purchased the property in 93. We worked very hard to pay this farm off, and have lived in a mobile home since buying the farm. We have a foundation just sitting there for a new home we planned to build! This farm was going to be our retirement with future development. I can't even begin to relate to you the problems this has created, a terrible, sad divorce in process, after 23 years of marriage, is at the top of the list. We were struggling with some issues, but were working through them. My husband simply couldn't face the fact that a 42" natural gas pipeline was splitting the farm in half! It was simply the icing on the cake! I have heart problems, and a double hip replacement in 04. I am presently on medical leave from my employment of 13 years as assistant
