



**MEMORANDUM IN SUPPORT**


The reason for the delay is a combination of both (1) a failure to appreciate that the application for renewal of certification was close at hand, and (2) the desire to include the most recent information regarding the financial status of VESI and that additional information took longer than expected to acquire. VESI is in the process of moving its operations into new offices and access to the most recent data and information is not currently accessible, but will be available in time for VESI to file its renewal application by October 12, 2007.

VESI maintains that this delay has not served to prejudice any party.

WHEREFORE, VESI respectfully requests that the Commission grant its Motion for Extension of Time pursuant to Section 4901-1-13(A), Ohio Administrative Code, for the reasons set forth above.
