On November 21, 2007, Industrial Energy Users-Ohio ("IEU-Ohio") filed a Notice of Depositions Duces Tecum indicating that IEU-Ohio intended to take the deposition upon oral examination of Edward B. Stein, Gregory F. Hussing, and any and all other witnesses that The Cleveland Electric Illuminating Company ("CEI"), Ohio Edison Company ("OE"), and The Toledo Edison Company ("TE") (collectively, "FirstEnergy"), or any of their parent companies or affiliates intends to call in the above-captioned cases on December 19, 2007, beginning at 10:00 a.m. After discussing witness availability, IEU-Ohio and FirstEnergy have agreed to reschedule the depositions of Messrs Stein and Hussing for January 9, 2008, beginning at 10:00 a.m. and continuing from day to day thereafter until completed, at the offices of McNees Wallace & Nurick LLC, 21 East State Street, 17th Floor, Columbus, Ohio 43215.

This examination will be conducted before a person authorized by law to administer oaths, and will be recorded by a licensed court reporter in accordance with Rule 4901-1-21(H), O.A.C.

The depositions will be taken of the aforementioned deponents on relevant topics within their expertise, including but not limited to, the subject matter of their testimony. Parties to the proceeding are invited to attend and cross-examine.

Additionally, pursuant to Rule 4901-1-21(E), O.A.C., and in compliance with Rule 4901-1-20, O.A.C., IEU-Ohio requests that the deponents bring with them to the deposition all documents that they have reviewed in preparation for testimony, all work papers that they have created or relied upon for these proceedings, and all discovery responses provided to parties in these proceedings that they were responsible for preparing on behalf of CEI, OE and TE, or any of their parent companies or affiliates.
