Dear Ms. Bose:

I am writing this letter in continued protest of the proposed location of the gas pipeline on my property by Rockies Express Pipeline, LLC ("REX") at 2629 Gardner Road, Hamilton, OH 45013.

I feel FERC has not addressed my concerns at all in its summary of comments in table 3.5-1 on page 3-31 of Draft Environmental Impact Statement REX East Project – Docket #CP07-208-000. Its summary of review also makes a false statement in that the stream would even enter into the move. (See diagram that shows location of stream). I am continuing to request that the proposed line be moved to the south under Duke Energy transmission lines and use that existing easement. Your Sarah McKinley has even stated to me that this is the normal preference of FERC in these circumstances. If this would not be possible (eg. Some conflict with Duke Energy), then I would request that the pipeline be moved further south as I have more land available on the southside of the center of the powerline as I do from the center north to the proposed center of the pipeline. I also would like to point out there are no transmission towers on my property, just overhead lines.

The main issue is us losing our adult shade trees, our parking area for our trailers, and our overflow parking we used for family events and guests. This was not even considered in the summary of review.


Attached (uploaded) are copies our first letters sent on 6/9/07, the second letter and sketch sent on 11/10/07, and pictures of the area's being discussed.






Mark in street marking proposed location of pipeline.

Dear Ms. McKinley:

I am writing this letter to reiterate my protest of the proposed location of the natural gas pipeline by Rockies Express Pipeline, LLC ("REX") on my property at 2629 Gardner Road, Hanover Township, OH 45013. My original letter dated 06.09.2007 is attached along with a sketch of my property to help FERC in understanding my discontentment in the location REX is wanting to utilize for their project.

The following are my four concerns:

- REX's selection of the pipeline location is just 56 feet from our home. (Measured from center of pipeline to edge of house.)
- REX's selection would destroy all the mature shade tree's on the south side of our lot #58.
- REX's selection would eliminate the overflow parking we have for family visits along with the parking we require for our 5th wheel travel trailer and a small enclosed trailer.
- REX's plan would abolish any future plans for me building a garage on my property as the proposed plans takes away the only level spot I have available for this to occur.

As you can see from the sketch, these is plenty of space to move the proposed pipeline over to our vacant lot using the existing Duke Energy existing easement. They could then alter the directional layout of the pipeline across Gardner Road since there is an abundance of free space on those vacant lots.

After my original letter and conversation with you, I was contacted by C.L Williams, Chief Inspector, and Richard Menke, Right of Way Manager, on 07.19.2007 who felt they did not want to change the proposed location mainly because they could not use Duke's existing easement. When I talked to you on 08.01.2007, you stated that FERC's position was to use existing right of ways when available. There is as much land on my property on the other side of the Duke Energy transmission lines as there is on the side they have chosen. The reason I believe REX will not even consider the other side is that it would require more work. (ie. That side of lot is not cleared, the side they proposed is

part of my yard that I keep landscaped and cleared out.) There is also another vacant lot (owned by Sanders Financial Group) on the south side of the Duke Energy transmission lines that would allow the pipeline to be located farthest away from inhabited households.

I am requesting that FERC demand REX to move their planned location under the Duke Energy Transmission lines or beyond in order to save our mature tree's, allow us to keep our auxiliary parking, and let us have the capability to use our land how we wish. REX officials said they would offer replacement trees, but I am 67 years old and don't think I would be around to enjoy the shade the new tree's would eventually provide many years down the road.

Please help us in this matter as it creates a lot of stress on us thinking that the home we worked so hard to obtain will be put in danger with the closeness of the planned pipeline and be naked without our mature trees.
