- Increase of the monthly recurring charges in the Verizon (Zone 1) area associated with the following residential and small business offerings: Residential RLA Service, Residential RLD-1 Service, Business B2 Service, Business Service B, and Business Service C. Affected customers were notified of the rate increases via an invoice message.
