Committee Chairmen and Members:

I understand that Ohio American Water Co. has approximately 52,000 water users in the state of Ohio and are associated in 17 other states.

I have lived in Imperial Estates in Mifflin Township, Mansfield, Ohio since 1967. There are approximately 300 homes in this allotment that the water company serves. Before American Water purchased this system from H. Robert Gimbel, my partner, Charles Parton, and I paid to put in a 130,000 gallon storage system adjoining the original existing wells on Biscayne Drive. The reason this was done was because Mr. Parton and I purchased 38 undeveloped lots from Mr. Gimble in Imperial Estates and we needed access to the water system. I sold the first house in 1962.

I can say that Ohio American Water has maintained the water system in working order.

I own and operate my own realty business at 737 Park Avenue West in Mansfield. I also have an upstairs apartment rented out. My total water/sewer bill for my business and apartment runs approximately \$30/month. Service is provided by the City of Mansfield.

At my personal residence I have a Richland County meter. Since 2006 the allotment has had 2 increases by Ohio American Water: 4/7/06 - \$63.39 bi-monthly and 6/6/07 - \$70.77 bi-monthly. A third increase is being proposed before the PUCO at present. The taxpayers in this allotment are asking you to please take a close look at the income/expenses of the Ohio American Water Co. I personally do not feel the Company is charging a fair and justified rate.


The homeowners in Imperial Estate use water meters on our lines coming onto our property by the Richland County Wastewater Department to read our monthly sewer bill. My question to you is, why can't Ohio American Water use the same equipment which is controlled by drive-by scanning or provide us with a rate reduction to \$60 bi-monthly?
