2. Maps showing the pipeline route as shown in the draft Environmental Impact Statement (DEIS) and the January 14, 2008 route revisions suitable for reproduction in black and white. All non-public information should be removed from the maps.
3. A legible black and white map showing the location of the proposed Hamilton Compressor Station (Bern site) and the pipeline route (both the DEIS location and the revised location).
