With this transmittal, Verizon is revising FCC No. 14 remove expired Specialized Service or Arrangements (ICBs).



8. On the next page, you will be shown a table of the filings that have been made for that tariff number starting with the most recent. Click on the part of the filing you want to view under the heading "View PDF". Each filing may have several parts, so look for the transmittal number on each line.


