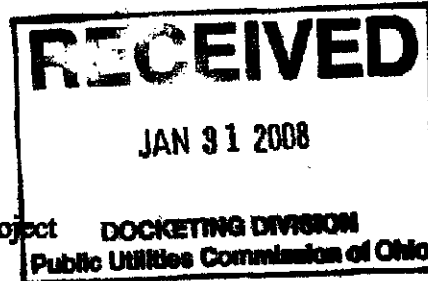

Supplement to Landowner List

Dear Ms. Bose:

On January 14, 2008, Rockies Express, in response to the issuance of a draft Environmental Impact Statement ("DEIS"), filed nine route variations for the REX-East Project in response to comments on the project.

On January 16, 2008, FERC Staff requested, among other things, that Rockies Express file a landowner list for the affected landowners for the nine route variations. On January 18, 2008, Rockies Express responded to the data request with, among other things, a landowner list for directly affected landowners crossed by the nine route variations.

Rockies Express hereby supplements the landowner lists provided to the Commission Staff to add the landowners who will "abut" directly affected properties — i.e., those landowners whose lands are not directly crossed by the project but own adjacent, or "abutting," land. This is consistent with the requirements of Section 157.6(d)(2)(ii) of the Commission's regulations, 18 C.F.R. § 157.6(d)(2)(ii) (2007). Rockies Express believes that nearly all of the landowners added to the list have been contacted by Rockies Express. Thus, nearly all directly affected landowners, or landowners who abut directly affected property, have been contacted by the FERC or by Rockies Express representatives.

Rockies Express regrets the error. In support of the FERC's outreach effort to landowners, Rockies Express intends to file an updated landowner list affected by the entire pipeline project on February 1, 2008.
