2   A1. My name is Joseph G. Bowser.

5   A2. Yes I am.

6   **Q3. What is the purpose of your Supplemental Testimony?**

7   A3. The purpose of my Supplemental Testimony is to reflect in my exhibits, where  
8       affected, the withdrawal of IEU-Ohio witness Kevin Murray's direct testimony in  
9       this case.

10   **Q4. How does the withdrawal of Mr. Murray's direct testimony affect your**  
11       **testimony?**

12   A4. On Revised JGB Exhibit 6 (admitted as IEU-Ohio Exhibit 12) and Revised JGB  
13       Exhibit 7 (admitted as IEU-Ohio Exhibit 13), I must remove from my proposed  
14       revenue requirements adjustments, the impacts of Mr. Murray's proposed  
15       adjustments for voltage and special contract discounts, for all three operating  
16       companies. Accordingly, I have included with this Supplemental Testimony,  
17       Supplemental JGB Exhibit 6 and Supplemental JGB Exhibit 7, which remove the  
18       revenue requirements impacts of voltage and special contract discounts.

19   **Q5. Does this conclude your supplemental testimony?**

20   A5. Yes, at the present time.


