Monroe delays gas pipeline talks

City has a number of concerns about Rockies Express' project.

MONROE — Monroe's Planning Commission postponed discussion regarding a site plan application from Rockies Express Pipeline Tuesday night, Feb. 19, until additional concerns can be resolved about the project.

Rockies Express proposes to build a \$33 million natural gas pipeline compressor station and electrical substation on a 23acre site south of Greentree Road and west of Interstate 75 with portions in Monroe and Turtlecreek Twp.

Rockies Express requested that the case remain on the table in an e-mail sent to the city Sunday, said Kevin Chesar, Monroe's director of development.

The commission initially delayed discussion about the site plan

Technician $An \downarrow$ Date Processed 2/21/08 application on Jan. 15. The five-member group agreed to leave the case on the table during its regular meeting upon the recommendation of Chesar.

"The city is working with Rockies Express to try to address various issues we have," Chesar said.

The concerns include mounding and landscaping requirements for the proposed project site, screening of structures, Homeland Security and disaster plan contingencies, fire suppression requirements that deal with waterlines and Ohio Department of Transportation proximity to Interstate 75 issues, he said.

Rockies Express also has given the city a sample plan for disaster plan contingencies that they've used at one of its other gas pipeline sites, he said.

"What we're looking into now is partly the water and fire suppression side of it, as well as some other outstanding issues (providing underground utilities to the site) that they need to address that we require from any site plan," Chesar said.

If all concerns are addressed, he said the commission could place the case back on the table for discussion at its next meeting at 6 p.m. on March 18.

The company says it needs to build a compressor station about every 200 miles to help pump gas along a planned 1,679-mile high pressure natural gas line that will stretch from Colorado to eastern Ohio.
