

As part of Rockies Express' response, provide all data sets for the hydraulic studies used to support the new flow diagrams. Submit all data sets in electronic format on CD or DVD. Please provide copies of the hard copy and the CD-ROM directly to Joseph Caramanica in Room 61-57.

2. Provide updated information showing the acreage and number of parcels, both temporary and permanent, required for the project. Show the percentages for which Rockies Express has obtained easements and for which Rockies Express expects to gain easements. Discuss the extent to which Rockies Express anticipates the need to rely on eminent domain to obtain easements. If you believe no condemnation will be required, provide justification for that belief.
