REX avoids approval

It looks like the Franklin County Commissioners will not have their day with Rockies Express Pipeline officials anytime soon

Rockies Express Pipeline is a proposed 1,678-mile natural gas pipeline system from Rio Blanco County, Colorado, to Monroe County, Ohio. It runs through Franklin County.

The Franklin County Area Planning office tentatively set aside February 25 for a REX hearing. According to Larry Franzman, Franklin County Area Plan Executive Director, REX officials planned to file a special exception. In a letter to Franklin County Commissioners, read at their Feburary 11 meeting, Franzman said REX officials do not plan to seek a special exception.

"Rockies Express is proceeding on the assumption that they will obtain a regulatory status as a utility and be exempt from the procedures required by local zoning," Franzman said in the letter.

According to Franzman, REX will seek regulatory status through the Federal Energy Regulatory Commission.

"They're dissing our county." Franklin County Commissioner Tom Wilson said. "They're not going to give us a chance to talk... It sounds to me like REX doesn't care what our concerns are."

Franklin County Surveyor Joe Gillespie said he does not think REX could meet Franklin County criteria for a favorable recommendation.

Up to this time, I have refused access to REX pipeline personnel for some of the final surveys mentioned on the attached -- pending our current on-going talks and negotiations with other potential legal counsel who specialize in eminent domain issues.

However, as our public prosecutor who has already actively pressed charges against this firm relating to other instances of their previously trespassing on private property, my constituent question is --

In your review of this enclosure, because this company has not yet knowingly received approved right of eminent domain, do I have to voluntarily immediately comply with their request in the prompt manner they described to avoid further legal consequences — as they suggest, or, can I continue at this point to legally refuse compliance without fear of further known legal reprisals or other complicated entanglements?

Because of the extremely short and sensitive time frame given by REX to reply in this regard, could you please advise — hopefully as absolutely soon as possible, and preferably in writing — so I won't inadvertently misquote your guiding opinion, as to my current property owner's rights in matters of this particular nature.

If you consent to REX entering onto your property in order to conduct its surveys and examinations, please sign and date this notice in the places indicated on the reverse side and mail it to REX no later than March 10, 2008, in the self-addressed, stamped envelope enclosed. A representative of REX will contact you to make arrangements for the surveys and examinations.

If you do not consent to REX's entry onto your property, or fail to sign and return this form by March 14, 2008, REX hereby notifies you of its intent to enter upon your property to conduct the needed survey(s) and examination(s) at a time of its choosing after March 14, 2008. In order to assure that its entry will not be impeded or obstructed, REX intends to initiate legal action to confirm its rights to conduct the needed surveys and examinations.
