
Gentlemen:

SMALL GENERAL SERVICE (SGS)

Applicability:

Applicable to customers listed on Appendix A to this Section.

Availability:

Available to all customers provided that the customer consumes less than 300 Mcf per year between September 1 and August 31. Annual consumption for customers served hereunder will be reviewed each August 31.

General Sales Rate:

All gas consumed per account per month, \$.19367 per 100 cubic feet.

A Customer Charge of \$6.50 per account per month, regardless of gas consumed.

An "account" includes all gas consumption which (1) is consumed by the same individual, governmental, or corporate entity, including subsidiaries and affiliates, and (2) occurs on property which is either contiguous or is separated by no more than the width of a public or private right-of-way.

Gas Cost Recovery:

In addition to the above rates, all gas consumed is subject to the Gas Cost Recovery (GCR) provision of Ohio Administrative Code Section 4901:1-14, and any subsequent amendments thereto, which section is incorporated herein by reference. A GCR rate of \$1.15874 per Ccf will apply to all sales.

Late Payment Charge:

Upon next-scheduled billing date, one and one-half percent (1-1/2%) will be applied to the unpaid balance of \$2,000 or more.
