Mr. Sipe,

Good afternoon, my name is Beckie Chase and I had the occasion to meet you recently at Edgewood High School in Trenton Ohio. Mr Sipe, the reason I am writing you is I received a phone call from my soon to be neighbor Shelly Waites this morning, and she was telling me about a visit to the neighboring property from some geologists recently and they were there because of Rockies Express gas line. This is not the first time these people have been out there but there seems to be some confusion as to where they are looking. You see lot 13 is where this line was originally suppose to go and because of some confusion with new surveyors they moved the line to lot 14, yet these visitors still go to lot 13 lot. I think they need some new paperwork or something so they go to the correct place. I also had a question as to the people who are suppose to be checking on endangered species. Shelly was telling me about these very small bats (almost like a large moth) that they have seen on our property and hers since she has lived there. We seem to think it is possible these could be Indiana bats the endangered species. Less than 5 miles as the crow flies they are planning on replacing a bridge on Liberty Fairfield Rd but will have to wait till next fall as they believe these bats are roosting in some trees that will have to be felled before the new bridge can be built. I was told of bats swarming from the cement pipe that goes under the road in front of our property and if this is a habitat the Indiana bat is using we need to make sure they are not disturbed until such a time as their young are ready to leave the area next fall. Could you please advise me who I can contact to see that this is checked out before Rockies decides to take all the trees they would roost in and deposit their young so they can feed. This area is a natural wet area with all the conditions needed for these bats. We have hickory, oak and numerous other trees on our property and there are dead and dying trees with plenty of scrub brush for them. This will all soon be gone along with the bats if we don't do something soon. Please tell me what to do.
