DESCRIPTION/RATIONALE

The Vaughnsville Telephone Company (“Vaughnsville”) hereby seeks authorization from the Commission to use the trade name, Vaughnsville Communications, when marketing its services and serving its customers in Ohio.

BACKGROUND

Vaughnsville is a not-for-profit incumbent local exchange telephone company providing basic local exchange service and associated telephone services in the Vaughnsville Exchange (approximately 315 access lines). Over the years, Vaughnsville’s array of services has grown beyond telephone service. Customers may now subscribe to DSL and video services as well. Accordingly, Vaughnsville has determined that use of the trade name, Vaughnsville Communications, will more accurately convey to its current and prospective customers that the company provides more than just telephone service.

Vaughnsville expects to begin operating under the new trade name on May 1, 2008. All else will remain the same. Vaughnsville’s terms and conditions of service will not be affected. Its legal name will not change; Vaughnsville Communications has been registered as a *trade* name with the Ohio Secretary of State (see Exhibit A attached hereto).

REQUEST FOR APPROVAL

Vaughnsville operates under the regulatory requirements established by the Commission in Case No. 05-1303-TP-COI. Those rules do not set forth specific requirements with respect to use of a trade name. Nor do the rules set forth an automatic timeframe for approval of such an application. Therefore, Vaughnsville has attached as exhibits to this Application those that would be required pursuant to Ohio Adm. Code 4901:1-6-14. Vaughnsville further requests approval of this Application within thirty (30) days of this filing. In addition to the trade name registration, attached hereto are the following exhibits:

- Exhibit B: Customer notice;
- Exhibit C: Affidavit attesting that customer notice has been provided; and
- Exhibit D: New tariff title sheets.

Vaughnsville provided customer notice via bill insert on February 29, 2008. The correspondence will provide customers with almost two months advance notice of the trade name change, inform them that all other terms, conditions, and rates will remain the same, and provide company contact information.

Vaughnsville hereby respectfully requests all necessary approvals and consents of this Commission for the use of the trade name as described herein and the tariff amendments.


